

BLOTTER SUMMARY

7/25/2022 through 7/31/2022

The Blotter reports below represent a selection of reports made between the dates above.

07/25/2022 11:43am A resident of the Clinton Street Center reported an odor of gas in her apartment. Pleasantville FD was dispatched, and the responding officer assisted the resident while the apartment was checked for natural gas. The results were negative.

7/25/2022 7:41pm Following a traffic stop on Marble Avenue for an equipment violation, it was determined that the driver was operating with suspensions to both his license and the vehicle's registration. The driver was placed under arrest and transported to PPD HQ for processing. He was issued the appropriate citations and released on his own recognizance to appear at a future court date.

07/26/2022 12:29am County Fire Control reported an automatic fire alarm activation at a residence on Washington Avenue. Pleasantville FD was requested to respond, and the responding officers advised that the alarm was set off by food on the stove. The scene was cleared by Pleasantville FD.

07/26/2022 2:12am A resident on Broadway requested medical assistance for severe abdominal pains. The responding officers provided medical assistance pending the arrival of the ambulance and the paramedic. The patient was transported to the hospital by Pleasantville VAC for further treatment.

07/26/2022 8:46am A resident on Weskora Avenue requested medical assistance for her husband who had a high fever and did not feel well. The responding officers provided medical assistance until EMS arrived. The husband was transported to the hospital by Pleasantville VAC.

07/26/2022 11:54am A caller on Bedford Road reported a low hanging wire over the roadway near the intersection with Pleasantville Road. Responding officers advised the wire

was a telephone wire. DPW was contacted and responded with a bucket truck to remove the wire, and Verizon was notified and responded to address the situation.

07/26/2022 5:26pm A Pleasantville resident reported that he had been involved in an auto accident on Bedford Road near the intersection with Pleasantville Road. While exiting from a gas station, one car pulled in front of another and they collided. The responding officer confirmed that there were no injuries, and completed a NY State Accident Report.

07/26/2022 9:19pm County Fire Control reported an automatic fire alarm at a residence on Washington Avenue. The responding officers discovered that the alarm activation was due to a malfunction in the system. The scene was cleared by Pleasantville FD.

07/27/2022 7:42pm An anonymous report was received of a woman having fallen off a motorized scooter and sustaining an injury on Sunnyside Avenue. The responding officers provided medical assistance until EMS arrived. The party was transported to the hospital by Pleasantville VAC for further treatment.

07/27/2022 9:11pm A resident of Clinton Street called to report an open door at a building on Tompkins Avenue. The responding officers checked the building and did not witness anything suspicious. The door was secured by the officers upon their departure.

07/28/2022 12:25am The central station monitoring system for an alarm company reported a commercial alarm activation at a business on Pleasantville Road. Responding officers checked the exterior of the building, and everything appeared secure.

07/28/2022 6:38pm A resident of Washington Avenue reported a green older-model Subaru travelling at a high rate of speed back and forth in front of her home. Officers canvassed the area with negative results.

07/28/2022 11:45pm Westchester County Police requested assistance, as two of their units were on Marble Avenue attempting to secure a patient for a mental health evaluation. Responding officers were able to render assistance and safely secure the party for the trip to the hospital.

07/29/2022 4:56am A resident on Brookview Drive reported the activation of his home's carbon monoxide detector. Pleasantville FD was dispatched to confirm the results. Responding officers and FD members worked to determine that the alarm was caused by a malfunction, and the home was deemed safe.

07/29/2022 6:40am The home health aide for a resident on Club Court reported that the man in her care had fallen during the overnight, and was unable to get up on his own. Responding officers located the man in his bed and requested the paramedic respond for a medical evaluation. Following the evaluation, the patient refused further medical attention and was left in the care of his aide. However, a few hours later, the man consented to going to the hospital, and was transported by Pleasantville VAC.

07/29/2022 4:00pm A resident of Yonkers came to Police HQ to report a hit and run motor vehicle accident at the intersection of Manville Road and Pleasantville Road. While waiting at the light to make a left turn, his vehicle was stuck in the rear by another vehicle, which then went around his vehicle and fled the scene. No injuries were reported to the driver or any of the four other passengers in the vehicle. A registration was provided from the driver, and the investigation is continuing. A NY State Accident report was filed.

07/29/2022 4:06pm Parks Department employees reported graffiti on the fieldhouse at Parkway Field on Marble Avenue. The responding officer noted that the graffiti was in the men's bathroom, and on the exterior rear wall of the building. The scene was processed for evidence, and the investigation is ongoing.

07/29/2022 7:35pm While on patrol, a Sergeant was flagged down by a pedestrian in regards to an escalating verbal dispute at the side of the road. Upon exiting his vehicle, the Sergeant was required to physically control a juvenile who adult staff members were attempting to return to her residential treatment facility. After successfully breaking away from the officer's grasp after multiple attempts, the juvenile was secured and placed under arrest. She was transported to Police HQ for processing, where she received an appearance ticket to Family Court and was returned to staff members.

07/29/2022 10:52pm Officers responded to the area of the Saw Mill River Parkway at Grant Street to assist Westchester County Police in stopping a stolen vehicle which had

previously fled from officers in another jurisdiction earlier in the evening. Officers were able to stop the vehicle and take the operator into custody without incident.

07/30/2022 1:31am An alarm company reported a broken glass activation alarm at a business on Cooley Street. Responding officers discovered damage to one exterior window, and the business owner was notified. He advised that the damage might be from a previous incident, and would confirm when he opened the business that morning. Officers began an investigation, including photographing the damage and canvassing the area for possible suspects and witnesses. The investigation is ongoing.

07/30/2022 8:57am The owner of an office building on Bedford Road reported the discovery of smoke grenades and a can of tear gas in a dumpster. The Westchester County PD Bomb Squad was notified and responded, and the items were removed for destruction without incident.

07/30/2022 8:57pm A resident of Washington Avenue reported three unknown parties entering an abandoned building near her home. When responding officers arrived, they observed three young men descending a chain link fence that surrounds the building. The officers were able to identify the three teenage males and followed up with their parents regarding the dangers of trespass upon abandoned buildings.

07/30/2022 9:18pm An agitated party entered Police HQ and alleged a sexual assault in progress to the Desk Officer. Without giving more details, he fled the building. Responding officers located a group of people involved in a verbal altercation on Marble Avenue near the intersection with Bedford Road and requested additional police assistance. Members of the Mount Pleasant PD and the MTA Police responded. The subsequent investigation revealed that the parties involved were AWOL from a local residential treatment facility, and that no sexual assault had been threatened or had occurred. The parties were counseled, and released to staff for transport back to campus.

07/31/2022 1:36AM Subsequent to a traffic stop for vehicle and traffic violations on Manville Road, a 32-year-old resident of Whitestone was placed under arrest for driving with a suspended license. The reporting officer processed the defendant at the scene and issued appropriate summonses and an appearance ticket for Village Justice Court.

07/31/2022 11:17am A Manville Road resident requested medical assistance for his mother who was unresponsive with shallow breathing. Officers entered the residence despite the presence of COVID positivity and administered oxygen until the arrival of EMS. The party was transported to the hospital by Pleasantville VAC for further treatment.

07/31/2022 6:01pm A resident of Golden's Bridge walked in to Police HQ and reported that she had parked her vehicle on Washington Avenue overnight, and when she returned in the morning it was gone. Responding officers searched the surrounding area and located the vehicle parked in Memorial Plaza. The party then remembered that she did, in fact, park it there.
