

BLOTTER SUMMARY

3/21/2022 through 3/27/2022

The Blotter reports below represent a selection of reports made between the dates above.

03/21/2022 5:38am The Central Station monitoring service for a business on Wheeler Avenue reported an alarm activation. Responding officers found an open door, so they searched the location but found no sign of entry. A keyholder was contacted, and officers advised him to contact the landlord to improve the physical security of the door.

03/21/2022 2:51pm An administrator from the Pleasantville High School requested assistance locating a student who had left campus. Upon arrival at the school, the responding officer learned the student had already returned to campus voluntarily.

03/21/2022 8:58pm The Mount Pleasant Police Department reported one of their officers is out with a property damage motor vehicle accident at the intersection of Marble Avenue and Bedford Road. Although no one was hurt, one of the vehicles had to be towed from the scene. A NY State Accident Report was filed.

03/22/2022 7:13am A resident of Wheeler Avenue requested medical assistance, as he had fallen and sustained an injury. Responding officers administered first aid while an ambulance and a paramedic were dispatched. The patient was transported to the hospital via Pleasantville VAC.

03/22/2022 9:54am An employee of the Pleasantville Recreation Department reported that she had found a credit card in the mailbox at the Recreation office. The Desk officer located the phone number of the cardholder and spoke to a family member. The card was destroyed when it was discovered that the card had already been cancelled.

03/22/2022 11:36am A patron of the Pleasantville Diner called to report her friend had just passed out, but is now conscious, and needs medical attention. Pleasantville ambulance and the on-duty paramedic were paged and responded. Officers treated the patient on scene, and she was transported to the hospital by Pleasantville VAC.

03/22/2022 6:35pm A driver requested assistance documenting a road rage incident on Marble Avenue in the vicinity of the intersection with Bedford Road. The driver reported he had been in conflict with the driver of another car, but the other driver had left the scene. The caller also stated he believed he may know who the other driver was, but a canvass for the second party yielded negative results. Since there was no damage to his car, he did not wish to proceed with an investigation. A report was generated.

03/22/2022 7:05pm A resident of the Clinton Street Center reported she had locked herself out of her apartment. Responding officers were able to gain entry.

03/22/2022 7:35pm A female driver from Briarcliff called to report a road rage incident that had just occurred on Marble Avenue in the area of in the area Center Street. The caller reported that while making a left to enter the Wood and Fire parking lot, the driver behind her began honking and yelling at her. After she had completed the turn, the driver exited her vehicle, addressed her directly with an angry expletive, and left the scene. A search for the second operator was negative.

03/23/2022 1:00pm This Department participated in a Mutual Aid drill conducted by the Westchester County Department of Public Safety. Participation included responding to a predetermined location with equipment appropriate for a mutual aid response.

03/23/2022 5:27pm A caller from the Old Village reported a U-Haul is parked in violation near the intersection of Broadway and Bedford Road. Responding officers determined the vehicle was parked legally.

03/23/2022 9:53pm A female caller reported that while driving north on Broadway, she observed a male wearing a green garbage bag walking in the middle of the roadway. Responding officers canvassed the area, but the man was not located.

03/24/2022 12:05am A resident of Dennis Lane reported that his wife was suffering the symptoms of a strong allergic reaction. Responding officers treated the woman while awaiting the arrival of the ambulance and paramedic. The patient ultimately refused further medical attention and declined transport to the hospital.

03/24/2022 4:32pm A central monitoring station reported an activated Fire Alarm at an auto repair center on Marble Avenue. The call was transferred to County Fire Control for a Fire Department dispatch. Responding officers determined that the alarm was set off in error by an employee.

03/24/2022 7:49pm This Department received a 911 hang-up from a residence on Seneca Lane. Return calls to the residence all resulted in a busy signal. Responding officers determined that the call was made in error by a member of the household.

03/25/2022 1:14am An administrator with a local group home requested assistance with a student who was AWOL from campus. The caller reported that the student had been located on the MTA platform, but was refusing to return with staff members to campus. Responding officers were able to convince the student to comply with staff member's requests.

03/25/2022 9:38am A driver on Pleasantville Road reported an auto accident with another vehicle. Responding officers determined that as one vehicle was pulled to the side of the road, it was struck by a second vehicle when the second driver did not notice that the car was stopped. One of the drivers required transport via Pleasantville VAC to the hospital, and one vehicle was towed from the scene due to damage. A NY State Accident report was filed.

03/25/2022 6:48pm County Fire Control reported an activated carbon monoxide alarm at a residence on Martling Avenue. Responding officers investigated with Pleasantville Fire Department members, and determined the alarm was set off in error by a contractor working on the home.

03/25/2022 8:08pm A Pleasantville resident reported her 8-year-old daughter had cut her arm and requested an ambulance. Responding officers and the paramedic determined the laceration to be minor and not in need of further emergency medical care. The mother declined the transport to the hospital.

An investigation determined that the owner of the bag was a female resident of Briarcliff. A short time after making contact with the family of the owner, her uncle arrived at Pleasantville PD HQ to retrieve the bag.

The ambulance and the paramedic were dispatched to the scene. Responding officers determined that she had lost consciousness during the service, but had regained consciousness prior to their arrival. The patient was transported to the hospital via Pleasantville VAC.

03/27/2022 7:16pm A Pleasantville resident called to report a trailer sticking out into the roadway on Bedford Road near the intersection with Broadway. The responding officer determined that the roadway was not obstructed.
