

BLOTTER SUMMARY

February 13 through February 19, 2023

The Blotter reports below represent a selection of reports made between the dates above.

02/13/2023 4:44am The central monitoring station for an alarm company reported an activated commercial burglar alarm at a local business on Pleasantville Road. Officers were dispatched, but the response was cancelled by the alarm company prior to their arrival.

02/13/2023 10:12am Following a telephone conversation, a woman requested a welfare check on her 93-year-old sister, who resides at the Clinton Street Center. The caller reported her sister was experiencing cognitive issues and appeared confused. The paramedic and Pleasantville Ambulance was dispatched, and officers assisted EMS personnel to assess the woman and prepare her for transport to a local hospital for further medical treatment.

02/13/2023 7:11pm A resident of Stanley Street requested assistance for a family member who had fallen and was unable to get up. Officers assisted the woman who had fallen, and assessed that she was not in need of further medical interventions.

02/13/2023 8:00pm A resident of Summit Place reported water in the roadway near his home. Officers confirmed a water main break, and DPW and Water Department personnel were notified and responded.

02/13/2023 11:30pm County Fire Control reported a woman shaking uncontrollably at a residence on King Street. The paramedic and ambulance were dispatched, and officers responded. Following an evaluation, the woman refused transport to the hospital.

02/14/2023 8:12am A DPW worker reported finding a cat in a box in a Village shed located in Memorial Plaza. Mount Pleasant PD was contacted for Animal Control to respond. While attempting to take custody of the cat, it ran away and was unable to be corralled.

02/14/2023 12:43pm A resident of Pleasantville reported a suspicious person walking on Bedford Road carrying a black trash bag, with what the caller believed to be a rifle

protruding from inside. Officers located the man a short distance away and determined the item in the bag was a walking stick. Upon further investigation, officers learned the man was from Missouri and currently unhoused. He was offered social services, but declined, and left the area of his own accord.

02/14/2023 7:12pm A resident from the Sherman Park area of Pleasantville reported a suspicious car that had been idling in her neighborhood for the past three hours. Officers determined the car was unoccupied and not running, but the headlights had been left on, and found nothing suspicious.

02/14/2023 8:07pm A resident of Manville Road reported that her bicycle had been stolen from in front of the restaurant while she was eating in a restaurant on Bedford Road. Officers responded to the area and conducted an investigation, which included canvassing for security footage and obtaining further information from the victim. A few hours later, a resident of Virginia Lane reported the bicycle abandoned in her front yard, and it was reunited with the owner. The case remains under investigation.

02/14/2023 8:50pm A resident of the Village requested a welfare check on her mother, who lives in Foxwood Condominiums, because her mother sounded strange during a recent telephone conversation. Responding officers found the woman appeared to be suffering from some type illness putting her into an altered mental state. EMS personnel were dispatched, and the patient was subsequently transported to a local hospital.

02/15/2023 7:07am A Bedford Road resident reported that she had fallen and needs assistance getting up. Responding officers determined she was not injured, and Officers responded and were able to render assistance.

02/15/2023 5:04pm A resident of Woodland Drive reported a man yelling racial slurs and derogatory remarks people as they pass by in the area of Wheeler Avenue and Manville Road. A description was provided, and officers canvassed the area but the man was gone. Approximately one hour later, officers located the man, who is known to this Department and interviewed him. He reported that the original incident stemmed from him shouting at a passing motorist who had failed to yield to him in the crosswalk. The man, who was unhoused, was determined not to be a threat to himself or others, was offered social services. He respectfully declined and went on his way.

02/15/2023 6:20pm The central monitoring station for an alarm company reported a commercial property alarm activation at a location on Marble Avenue. Upon arrival, officers discovered an open door, so they searched the building but found no signs of suspicious activity. The building was re-secured upon the officer's departure.

02/16/2023 11:48am A contractor working at a construction site reported a sexual assault involving a female coworker and a sub-contractor fifteen minutes in the past. Officers and detectives responded and determined that the suspect had already left the scene. The victim filed a deposition, and the suspect was contacted to return to Police HQ in the future. When he did so, he was arrested and charged with Forcible Touching, an A Misdemeanor. He was processed and brought before the Village Justice for arraignment. An Order of Protection was issued for the victim.

02/16/2023 2:53pm A local resident reported a disturbing exchange at the intersection of Bedford Road and Romer Avenue during school dismissal. According to the caller, a black SUV disregarded the Crossing Guard's request to stop while she was crossing pedestrians, causing the crossing guard to step in front of the vehicle to prevent it from moving forward. The caller further reported that a male passenger in the car leaned out of the window and screamed expletives and sexually offensive comments to the crossing guard before the SUV continued down Romer Avenue toward the High School. Officers were dispatched and canvassed the area but were unable to locate the vehicle. Upon speaking to the Crossing Guard, she stated she did not hear anything offensive, and was unaware a complaint had been made.

02/16/2023 4:28pm A resident reported a vehicle parked on the road near her home without license plates. The responding officer observed the vehicle to have dealer assignment plates. Both the displayed plates and the vehicle's vehicle identification number were valid, and the vehicle was parked legally and not in violation.

02/16/2023 7:48pm Following a dispute over the servicing of her vehicle, a local resident requested documentation of the incident. Officers interviewed both the caller and the location manager, and filed a police report. The customer was provided with further information on how to pursue matter civilly or with the corporate office.

02/17/2023 12:46am A medical alert company reported a resident of Foxwood Drive had fallen and was unable to get up. Responding officers determined that the woman was not injured, and that medical attention was not needed. Officers assisted the woman to her feet.

02/17/2023 10:00am County Fire Control reported a woman feeling as if she were about to pass out at her home on Washington Avenue. EMS was dispatched, and responding officers administered first aid while awaiting their arrival. The patient was transported to the hospital via Pleasantville VAC. the Westchester Medical Center for treatment.

02/17/2023 7:09pm The central monitoring station for an alarm company reported a burglar alarm activation at a residence on Ashland Avenue. Officers checked the exterior of the home and observed no forcible signs of entry as the residence appeared secure.

02/17/2023 8:45pm County Fire Control reported an inside odor of smoke at a local business on Irvington Street. Police and Pleasantville Fire Department responded and after checking the inside of the business, it was discovered that there was an issue with the boiler.

02/18/2023 5:00am Despite posted warnings, four (4) vehicles were impounded from the Memorial Plaza Lot for violating the parking restrictions for the Farmer's Market.

02/18/2023 10:52am A woman walking in the Country Club reported she had come across an elderly woman who had fallen and sustained injuries. The ambulance and paramedic were dispatched, and responding officers attempted to keep her comfortable awaiting the arrival of EMS. The patient was transported to the hospital for treatment via Pleasantville Ambulance.

02/18/2023 11:58am County Fire Control reported a Washington Avenue resident feeling dehydrated in his home. Upon arrival, officers learned the man may be positive for COVID-19. Precautionary protocols were followed, and the patient was transported to the hospital by Pleasantville VAC for treatment.

02/18/2023 2:16pm A local resident reported a young man allegedly breaking glass on the sidewalk in front of the Bedford Road School. Responding officers located the young man, a resident of the Bronx, and learned that he was selling candy door to door and had accidentally dropped two candles on the sidewalk, causing them to break. The young man was informed that door to door soliciting required a permit, and he was given a ride to the train station to return home.

02/18/2023 7:02pm A resident of Staten Island reported multiple unauthorized charges to a gift card he had inadvertently left behind at a local restaurant. After using the card the previous day, four sperate charges were transacted against the card's balance. Restaurant staff cancelled the transactions and refunded the money. The card's owner wished no further police action and only wanted the incident documented to facilitate a replacement card.

02/18/2023 8:40pm A Police Department in New Jersey requested assistance locating a former resident of Pleasantville who had been accused of making threats of violence against a business in their jurisdiction. Since the party involved was known to this Department, the requesting agency was provided information on the correct jurisdiction to contact.

02/19/2023 1:13am A caller from Pleasant Avenue reported a group of youths outside his home who appeared to be fighting. Responding officers located the "youths", who were in fact a group of adult women walking home, and they were asked to be mindful of the noise.

02/19/2023 10:10am County Fire Control reported a woman with difficulty breathing at an apartment on Wheeler Avenue. Responding officers administered oxygen while awaiting the arrival of the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

02/19/2023 2:45pm A resident of Saratoga Avenue reported three vehicles he believed were abandoned parked along the railroad tracks. The responding officer determined that all vehicles were registered, and the one vehicle that was not parked legally was relocated to a legal spot by the owner.

02/19/2023 6:12pm A 911 call was received from a local residence for a 4-year-old child not breathing. Upon arrival, responding officers found the child to be breathing on his own and recovering from an apparent febrile seizure. Oxygen was administered while awaiting the arrival of the ambulance and paramedic. The patient, along with his parents, were transported to the hospital via Pleasantville VAC.

02/19/2023 9:58pm A resident of Dennis Lane reported his neighbor's garage door and the family's vehicle trunk both open. Responding officers located the homeowners inside the residence, who explained they had just returned from a trip and had inadvertently left them open.
