

BLOTTER SUMMARY

February 6 through February 12, 2023

The Blotter reports below represent a selection of reports made between the dates above.

02/06/2023 5:00am County Fire Control reported a fire alarm activation at an apartment complex on Vanderbilt Avenue. Patrol Officers and Fire Department personnel responded and searched the area, but found no sign of fire. The area was cleared when the activation was determined to be an alarm malfunction.

02/06/2023 10:00am An employee of a business on Tompkins Avenue reported suspicious activity in the wooded area behind their building. Responding officers located an unhoused man who had erected a temporary shelter and had been living in the woods for an unknown amount of time. A homeless outreach organization was contacted but was unable to respond, so they will follow up in the next few days in an attempt to help this individual. The man refused any type of assistance or services at the time of the contact, and left the area willingly. Officers and DPW worked to clear the encampment.

02/06/2023 11:18am A resident of Foxwoods Condominiums reported that she had recently returned home from a brief hospital stay and discovered items had been stolen from her residence. Responding officers checked her apartment and found the items, a small safe and four (4) umbrellas, located in another part of the unit. The caller realized her error and agreed that no crime had been committed.

02/06/2023 5:50pm County Fire Control reported an active structure fire on Highview Terrace. Pleasantville Fire Department and surrounding Fire Departments with police responded to the location. Upon arrival the deck of the home was on fire and personnel rushed to make sure the house was empty. A canine was rescued from the home and placed in the care of a neighbor. The fire was extinguished by Pleasantville Fire Department and the scene was made safe by the Pleasantville Fire Department. The homeowners arrived and made arrangements for where to stay.

02/07/2023 2:06pm An administrator at Pleasantville High School requested EMS for a 52-year-old female experiencing pain and elevated blood pressure. Officers responded and assisted the paramedic and the ambulance crew in preparing her for transport. The patient was taken to the hospital via Pleasantville VAC.

02/07/2023 3:57pm Following a 911 hang-up call, the Desk officer attempted multiple times to contact the caller via telephone. When that was unsuccessful, officers were dispatched to the residence on Cedar Lane to assess the situation. Upon arrival, officers were met by the homeowner, who reported that all was in order.

02/07/2023 5:34pm A resident of Manville Road reported a car blocking access to their driveway. The responding officer issued a summons.

02/07/2023 8:12pm A mother who lives on Lenox Avenue reported her 42-year-old son was experiencing heart palpitations and feeling like he was going to pass out. Pleasantville Ambulance and a Medic were dispatched. Officers on scene administered basic First Aid until EMS arrived, and the patient was subsequently transported by Pleasantville VAC to a local hospital for further medical treatment.

02/07/2023 10:58pm An elderly resident of Marble Avenue reported a leak in her hot water system that was putting water in her basement. Officers and Pleasantville FD personnel assisted the woman to stop the leak pending the arrival of a plumber.

02/08/2023 1:30am The central monitoring station for an alarm company reported a residential burglar alarm activation at a residence on Weskora Avenue. Upon arrival, responding officers were met by the homeowner, who stated his adult son had accidentally activated the alarm when leaving the residence.

02/08/2023 10:48am County Fire Control requested officers and medical personnel respond to a residence on Great Oak Lane for a woman having chest pains. Officers provided oxygen and kept her comfortable pending the arrival of the ambulance and the paramedic. The patient was transported via Pleasantville VAC to the hospital for further evaluation.

02/08/2023 1:16pm A home health aide called 911 to request assistance for her client, an elderly resident of Academy Street, who was having difficulty breathing. EMS personnel were dispatched, and responding officers administered oxygen pending their arrival. The patient was transported via Pleasantville VAC to the hospital.

02/08/2023 4:42pm The owner of a commercial property reported a door ajar at the location, and was unsure if there had been a break-in. Upon arrival, responding officers found the door wedged open. Patrol officers and Detectives searched the building but found no signs of occupation. Perimeter camera footage was checked with negative findings. The owner re-secured the door with new locks.

02/08/2023 7:20pm A resident of the Clinton Street Center called to report she had pneumonia and requested transport to the hospital. The paramedic and an ambulance were dispatched, and officers attempted to keep her comfortable pending their arrival. The patient was transported to the hospital via Pleasantville VAC for further evaluation.

02/09/2023 11:24am Westchester County Police reported they were following a car reported stolen on the Saw Mill Parkway approaching Pleasantville. Patrol and Detective units responded, and the vehicle was stopped on Pleasantville Road, resulting in the arrest of the driver.

02/09/2023 11:30am An anonymous caller reported low-hanging utility wires on Bedford Road near the Old Village. The responding officers determined the lines were not power lines and were able to correct the situation.

02/09/2023 3:29pm A resident of the Village came to Police HQ and requested police serve a Family Court Order of Protection upon her husband at their residence on Saratoga Avenue. Due to a language barrier, a Spanish-speaking Officer from the Westchester County Police responded to translate. Officers located the husband there and issued the paperwork to him without incident.

02/09/2023 7:51pm County Fire Control reported a 50-year-old man experiencing blurry vision at his residence on Hillview Drive. Responding officers assisted EMS personnel, and the patient was transported to the hospital via Pleasantville VAC.

2/10/2023 5:14am A home health monitoring company reported a woman needing assistance after a fall in her apartment at the Clinton Street Center. Responding officers determined she was not injured and helped her back to her feet.

02/10/2023 8:07am County Fire Control reported a carbon monoxide alarm at a business on Bedford Road. Pleasantville Fire was dispatched and requested Con Edison to respond. PD Officers assisted with securing the scene during the investigation, and the location was eventually deemed safe by Con Edison.

02/10/2023 11:21am The central monitoring station for an alarm company reported that a Door Dash driver had activated a silent panic alarm somewhere in the Village. A description was provided, and responding officers located the driver and his vehicle on Wheeler Avenue. The driver reported there was no issue, and that he had not intended to send the alarm. Further investigation revealed the alarm was triggered by an app in the car.

02/10/2023 11:47am A resident of Booth Street reported a tree branch down on Pleasantville Road. Responding officers found that DPW personnel had already addressed the situation.

02/10/2023 5:00pm The central monitoring station from an alarm company reported a carbon monoxide alarm activation at a residence on Washington Avenue. Officers responded, and coordinated with Pleasantville FD on scene. After further investigation revealed the alarm was set off in error by the homeowner while changing the battery in the alarm, and FD personnel cleared the scene for safe reentry.

02/11/2023 5:00am Despite posted warnings, three (3) vehicles were impounded from the lot in Memorial Plaza for violation of parking restrictions for the Farmer's Market.

02/11/2023 7:05am A resident of Washington Avenue requested assistance at his home, as he was having an argument with his mother, with whom he resides. Upon arrival, officers determined that no crime had been committed and the issue had already subsided. Both parties were interviewed, and a NY State Domestic Incident report was filed to document the incident.

2/11/2023 8:15pm A resident of Leland Avenue reported that while walking his dog on Lake Street, he thought he had observed two youths on the secured Village Pool property. Responding officers located two young women in the area, who stated they had been on the basketball courts and the playground, but were never in a prohibited area.

02/11/2023 11:51pm A resident of the Village reported via 911 that his father had just had a seizure. EMS personnel was dispatched, and responding officers provided basic medical care until the ambulance and paramedic arrived. The patient was transported to the hospital via Pleasantville VAC.

02/12/2023 9:23am Resident of the Village entered Police HQ to make report of updated order of protection from Putnam County Family Court as well as to file allegations that the father of her child has violated such court order. Officers obtained a deposition from her and will follow up with the District Attorney to decide the appropriateness of further criminal charges.

02/12/2023 1:24pm A resident of Pleasant Avenue reported that a child had discovered a used, uncapped syringe in the area of the Saw Mill River near Pleasant Avenue a few days in the past. While the item had since been discarded, the resident wanted to advise the Police Department of the possibility of illegal activity in the area. Officers conducted a canvass for further contraband or signs of criminal activity with negative findings.

02/12/2023 5:30pm A woman came to Police HQ to report a domestic disturbance that occurred approximately an hour before in her car in Memorial Plaza with the father of her child. She reported that following an argument, he had struck her in the arm repeatedly, in the presence of their young daughter. The victim provided a supporting deposition and officers completed the evidence collection necessary for a criminal prosecution. The suspect, a 27-year-old resident of the Village, was subsequently arrested near his home and charged with Assault in the Third Degree and Endangering the Welfare of a Child. He was processed and brought before the Village Justice for arraignment and the issuance of a Temporary Order of Protection.

02/12/2023 8:48pm Following a traffic stop for an equipment violation, it was discovered that the operator, an 18-year-old man from Yonkers, did not possess a valid Driver License. The operator was issued multiple traffic summonses and the vehicle was impounded.

02/12/2023 10:05pm An anonymous caller reported an erratic driver in the area of Sunnyside Avenue and Clinton Street. The caller provided a vehicle description, and the car was located by patrol officers a short time later on Marble Avenue. Since the violations had not occurred in the officer's presence, no tickets could be issued, but the driver was warned about the consequences of unsafe vehicle operation.
