

## **BLOTTER SUMMARY**

**August 8 through August 14, 2022**

The Blotter reports below represent a selection of reports made between the dates above.

08/08/2022 12:05pm County Fire Control reported an inside odor of gas at an establishment on Wheeler Avenue. The responding officers were met at the scene by Pleasantville FD and Con Edison personnel. The Con Edison crew was able to locate the leak and resolve the problem.

08/08/2022 12:39pm A resident of Valhalla requested a welfare check on her niece, who lives in the Village and who had not returned repeated phone calls. The caller was at her niece's residence and could hear water running inside, but there was no answer to the knocking on the door. Officers secured a key from the landlord and entered the apartment, but the niece was not there. The water in the shower had been leaking, causing the noise that had been heard outside.

08/08/2022 6:50pm A resident of Weskora Avenue called to report an issue with his adult son who lives at home. Upon arrival, officers were informed that the dispute was over money, and the father had called because he did not wish the incident to escalate. A NY State Domestic Incident Report was filed, and the son agreed to leave the house for the night.

08/08/2022 10:52pm An employee of a restaurant on Marble Avenue reported that a party had entered the restaurant with a head injury sustained from a fall. Responding officers treated the bleed while awaiting the arrival of the ambulance and the paramedic. The patient was transported to the hospital by Westchester EMS.

08/09/2022 2:46am County Fire Control requested an ambulance respond to a residence on Bismark Street for a man not feeling well. Upon arrival, responding officers advised that the paramedic was on scene and providing aid. The patient was transported to the hospital by Pleasantville VAC.

08/09/2022 11:09am The daughter of a resident on Guion Street requested assistance getting her father off the floor after a minor fall. Officers were able to assist the man off the floor and determine he was uninjured. He refused further medical assistance.

08/09/2022 12:18pm A resident of Martling Avenue reported vehicles parked over the posted time limit and in violation on his street. The Parking Enforcement Officer was advised and will monitor and handle the situation.

08/09/2022 1:43pm Following a traffic stop on Pleasantville Road, PO Smith determined that the New Jersey temporary license plate on the vehicle was fraudulent. The driver was placed under arrest and charged with Forgery in the 2<sup>nd</sup> Degree. The defendant, a resident of Ossining, was transported to Police HQ for processing, after which he was released on his own recognizance to return to Village Justice Court at a later date. The vehicle was impounded.

08/09/2022 9:02pm PO Saetta conducted a traffic stop on Center St for an equipment violation, and discovered the operator was driving a vehicle with a suspended registration while having a suspended license. The driver was processed on scene, issued traffic tickets, and released without incident to return to court at a later date.

08/09/2022 9:19pm A Village resident noticed a power line sparking on Wheeler Avenue. Offices secured the scene while awaiting the arrival of Con Edison.

08/10/2022 10:42am An 88-year-old female resident fell while crossing the street at the intersection of Manville Road and Wheeler Avenue. Officers provided first aid while awaiting the arrival of the ambulance and the paramedic. The patient was transported to the hospital for treatment of her injuries.

08/10/2022 12:35pm A resident of White Plains came to Police HQ to report he had been the victim of a scam. After finding an apartment located at 600 Bedford Road for rent online, he contacted the person he believed to be in control of the property. After sending personal identifying information to the purported landlord, he arrived for a showing only to find the apartment is not for rent, and the owner has no knowledge of the perpetrator. The investigation is ongoing.

08/10/2022 3:54pm A resident of Mount Pleasant reported a large tree branch in the roadway on Lake Street. The responding officer was able to move branch out of roadway and place it back into the woods.

08/10/2022 8:38pm A resident of the Village reported a domestic dispute with his adult son in which the son damaged a television set. The son, who still lives at the family home, was arrested for Criminal Mischief in the Third Degree and transported to Police HQ, where he was processed and held for arraignment in Pleasantville Justice Court. A NY State Domestic Incident Report was filed. An Order of Protection was issued by the judge, and he was released on his own recognizance.

08/11/2022 10:16am The property manager from the Clinton Street Center reported finding graffiti in multiple locations on the grounds of the building. Patrol officers documented the scene and began a preliminary investigation, and the case was eventually turned over to the detective division for further investigation.

08/11/2022 11:59am A resident of Washington Avenue called 911 to request an ambulance for herself after she fell off her bike earlier in the day. Officers found the woman in her kitchen with a complaint of pain in her hip, so they kept her comfortable pending the arrival of the ambulance and the paramedic. She was transported to the hospital via Pleasantville VAC.

08/11/2022 12:39pm A resident of Greenmeadow Road reported that he was just involved in an accident in Memorial Plaza where the other driver left the scene. Although no one was injured, a three-month old baby was in the caller's vehicle when the accident happened. The driver and a witness gave matching descriptions of the vehicle and the driver, who was identified as a resident of Ossining. When he returned to Pleasantville to complete the report, he was issued a summons for Leaving the Scene of an Auto Accident (Property Damage). A NY State Accident Report was filed.

08/12/2022 1:42 pm Multiple callers reported a three-car accident on Broadway. Upon arrival, responding officers discovered that one driver had been injured, so they requested an ambulance and the paramedic. The injured driver was transported by Pleasantville VAC to the hospital, and a NY State Accident Report was filed.

08/12/2022 9:12pm A Stanley Street resident called to report loud music coming from a restaurant on Marble Avenue. Officers arrived and advised there was no violation or unreasonable noise at the location.

08/13/2022 5:24am The central station monitoring system for an alarm company reported a commercial burglar alarm activation on Tompkins Avenue. Responding officers checked the perimeter and determined the building to be secure on the ground level.

08/13/2022 8:22am A Center Street resident requested assistance for his mother who had fallen out of bed. Officers determined the party was in need of additional medical attention, so the paramedic and an ambulance were requested to respond. The patient was transported to the hospital via a mutual aid ambulance.

08/13/2022 2:22pm An employee of the Post Office in Memorial Plaza reported that he was concerned for an elderly man who had entered the Post Office and apologized for being late to work. Responding officers spoke to the man, who is a resident of the Village and had worked at the Post Office decades ago. The paramedic was requested to provide a medical clearance. The man was able to provide the name of a family friend who was known to the responding officers, so they contacted the friend to take the man home.

08/14/2022 9:54pm A resident of Greenmeadow Road reported a dispute between her ex-husband and their adult son. Responding officers determined that the dispute was over money, and that the son does not reside at residence. Officers completed a NY State Domestic Incident report and the son left the scene without further incident.
