## **BLOTTER SUMMARY**

## August 15 through August 21, 2022

The Blotter reports below represent a selection of reports made between the dates above.

08/15/2022 12:54pm A resident of Hays Hill Road came to Police HQ to surrender ammunition he had found while cleaning out his house. The ammunition was taken into possession and designated for destruction.

08/15/2022 2:03pm A resident of Irvington Street reporting multiple vehicles parked in violation, making it difficult to drive down the roadway. The responding officer was able to locate the vehicle owners and have them moved without incident.
