

BLOTTER SUMMARY

August 22 through August 28, 2022

The Blotter reports below represent a selection of reports made between the dates above.

08/22/2022 4:40am A resident of Hopper Street reported noise coming from some people congregating in the area of his home. Responding officers located a group outside of a residence on Marble Avenue and asked them to refrain from making unreasonable noise.

08/22/2022 7:38am Mount Pleasant PD advised they had received a 911 hang-up call from a residence on Marble Avenue in Pleasantville's jurisdiction and had gotten no answer on a call-back. Responding officers checked the location and found no one was home.

08/22/2022 9:35am A resident of the Clinton Street Center requested medical assistance because she was feeling weak. Responding officers kept the woman comfortable while awaiting the arrival of EMS personnel. The patient was transported to the hospital for further treatment via Pleasantville VAC.

08/22/2022 3:15pm A resident of Mahopac came to Police HQ to report a man panhandling on Marble Avenue. The man, who is known to this Department and is currently unhoused, was located and advised that panhandling is not allowed. He left the area without further issue.

08/22/2022 8:41pm The daughter of a resident of Guion Street called to report that her father needed assistance getting up from a fall. Responding officers assisted him up, and requested a paramedic respond to do a medical evaluation after he complained of pain. The man refused further medical intervention after the evaluation and was left in the care of his home health aide.

08/22/2022 11:35pm An AWOL student from a residential treatment facility walked in to Police HQ and stated that he was having suicidal thoughts. Officers stayed with the party in the lobby while the desk officer requested a paramedic and an ambulance. The facility was

advised of his whereabouts, and the young man was transported to the hospital for a mental health evaluation and further medical treatment.

08/23/2022 2:33am A Yorktown Heights resident contacted the Pleasantville Police requesting assistance in finding his 23-year-old daughter, whom he believed was at a residence on Grant Street. The responding officers were able to locate the daughter, who had been sleeping at a friend's house. Father and daughter were reunited, and the daughter returned home with her father.

08/23/2022 11:27am A resident of Clinton Avenue requested medical assistance for her husband, who had fallen and hit his head. The responding officers provided medical assistance for a laceration to the head. Upon the arrival of EMS personnel, the husband was evaluated and spoke with EMS and decided to refuse any further medical attention.

08/23/2022 7:20pm Mount Pleasant PD requested Pleasantville ambulance to respond to a restaurant in Thornwood. The call originated as a man refusing to leave restaurant but upon MPPD officers arriving, the male party was disoriented and needed to be evaluated. Male party was the same party panhandling on Marble Ave on the previous date. Party was taken to the hospital for further assistance.

08/24/2022 2:10am A resident from Washington Avenue reported a suspicious vehicle parked for an extended length of time in front of her residence with the lights on and the vehicle running. Additionally, the caller stated he had observed the vehicle being driven erratically before it stopped. Responding officers located the vehicle and interviewed the driver, who did not show any signs of impairment and who was just tired after coming home from work. The driver entered his own residence, which was across the street from the caller's house.

08/24/2022 12:34pm A party came into Police HQ reporting that he had locked his keys in his vehicle while it was parked in Memorial Plaza. The responding officer was able to make entry into the vehicle without incident.

08/24/2022 6:41pm A resident of Manville Road called to report illegal parking in the area of Soldier's and Sailor's Field. The responding officer found no cars parked in violation.

08/25/2022 8:43am A resident of Edgewood Avenue requested medical assistance for an elderly relative who was having trouble breathing. The ambulance and paramedic were dispatched, and responding officers provided medical assistance until EMS arrival. The party was transported to the hospital by Pleasantville VAC.

08/25/2022 11:17am An unauthorized tractor trailer was reported stopped on the Saw Mill River Parkway north of the Manville Road exit. Westchester County PD was notified, and the responding Pleasantville PD officers assisted in backing the trailer off of the parkway.

08/25/2022 3:35pm A resident of Chappaqua reported that she had just been involved in a car accident on Washington Avenue in which she struck a dog. The responding officers interviewed both the driver and the dog's owners, and it was determined that the driver did not have enough time to avoid hitting the dog as it ran out into the street. The dog was taken to a local animal hospital, and is expected to make a full recovery.

08/25/2022 6:21pm An employee of a local establishment on Cooley Street called to report that a man had passed out at inside the bar area. The paramedic and the ambulance were requested, and officers provided medical assistance until EMS arrival. It was determined that the man had lost consciousness due to a medical issue, and the patient was transported by Pleasantville VAC to the hospital.

08/25/2022 8:22pm The same employee of a local establishment on Cooley Street reported that another patron had passed out. The ambulance and paramedic were dispatched. Responding officers determined that the individual had a seizure and provided medical assistance until EMS arrived. The party was transported to the hospital by Pleasantville VAC.

08/26/2022 5:45am Several callers reported a large tree branch blocking Sunnyside Avenue near the intersection with Tompkins Avenue. Responding officers were able to move a portion of the branch to make way for vehicular traffic, but requested DPW be notified for the remaining section. DPW responded to the scene, and was able to completely clear the roadway.

08/26/2022 12:30pm A village resident came to Police HQ to report that his bank had informed him of an attempted larceny from one of his accounts. A person had called the branch

and purported to be the victim and provided personal identifying information to the bank employee. The bank employee declined the transaction because he personally knew the victim. Although no money was actually taken, officers believed there was information that could warrant an investigation. A report was filed and forwarded to the Detective Division.

08/26/2022 12:59pm A Hawthorne resident reported that her vehicle had been involved in a minor accident in front of the Wells Fargo bank on Washington Avenue. Responding officers determined that a South Salem resident was attempting to park his recreational vehicle (RV) in a spot and collided with the caller's vehicle. There were no injuries, and a NYS Accident Report was filed.

08/26/2022 3:48pm A village resident reported that a portable speaker that had been attached to his bicycle was stolen by a group of youths while the bicycle was parked in Memorial Plaza. The responding officer spoke with the complainant, who was able to provide the name of a possible suspect. The information was turned over to the detective division, and after a lengthy investigation, the youths responsible were located and the speaker was returned to the complainant.

08/26/2022 5:10pm An employee of a business on Washington Avenue requested assistance for an unwanted patron who had remained inside the store for an extended period of time. The responding officer located the customer, who is known to this department, and informed him that he was no longer welcome. The customer was escorted from the business without incident, and advised not to return.

The responding officers interviewed both parties and determined that no crimes were committed. After de-escalating the situation, officers resolved the situation by getting both parties to agree to separate for the remainder of the evening, and a NYS Domestic Incident Report was filed.

08/26/2022 7:09pm A resident of Bedford Terrace reported cars parked on both sides of the street near the intersection with Bedford Road. The responding officer issued multiple parking summonses.

Responding officers determined that the current dispute was connected to the prior domestic dispute. The ambulance and a paramedic were requested for an intoxicated party. The patient was transported to the hospital by Pleasantville VAC, and another NYS Domestic Incident Report was filed.

08/27/2022 12:08am A resident of Washington Avenue requested assistance for a bat in their house. The responding officers advised that a trapper had been contacted by the homeowner while they were in route, and that he would be coming out to remove the bat.

The ambulance and a paramedic were requested, and responding officers provided medical aid pending their arrival. The party was transported to the hospital by Pleasantville VAC.

The responding officers located the animal and observed that the skunk was sick. Using great care, the animal was destroyed in the interest of public safety.

08/28/2022 8:29am A resident of Wheeler Avenue requested assistance gaining entry into his vehicle. The responding officer advised that he was able to unlock vehicle, which needed a new battery for its keyfob.

Officers were able to assist staff members to control his movements and de-escalate the situation. EMS Personnel were requested to respond and the youth was transported to the hospital by Pleasantville VAC for further treatment.
