BLOTTER SUMMARY

September 5 through September 11, 2022

The Blotter reports below represent a selection of reports made between the dates above.

***PLEASE NOTE: Animal complaints regarding raccoons that appeared to be rabid continued into a second week. The Pleasantville Police Department has been in communication with the Department of Environmental Conservation to address any underlying issues that may be circulating within our animal population. At this time, DEC officials have stated the evidence points to an outbreak of distemper, which is not transmittable to humans, and one of the animals involved has been secured for testing. However, contact with wild animals should still be avoided and care should still be taken around any animal, especially one that is showing signs of illness or impaired mobility and / or motor control. ***

09/05/2022 2:30am County fire Control reported a commercial fire alarm at a business on Marble Avenue. Pleasantville FD was dispatched, and responding officers reported the alarm was a malfunctioning smoke alarm. The alarm was reset, and the scene was cleared by the Fire Department.

09/05/2022 8:27am A resident of Brookview Drive reported a raccoon in his backyard that appeared sick. Responding officers located the raccoon and verified the animal was exhibiting signs of illness. The animal was safely and humanely destroyed.

09/05/2022 1:48pm A resident of Eastview Drive reported a possible sick raccoon. The responding officers advised that the animal was destroyed, and the carcass was removed by the homeowner.

09/05/2022 7:34pm The central station monitoring system for an alarm company reported a commercial burglar alarm activation within the Village. Responding officers walked the premise and checked all entry/exit points, and deemed the location secure.

09/06/2022 1:14am County Fire Control reporting a party in possible cardiac arrest at a residence on Washington Avenue. Responding officers found the party awake and alert, but

confused, upon arrival. The officers provided oxygen until the ambulance and the paramedic arrived. The patient was transported to the hospital by Pleasantville VAC for further treatment.

Responding officers completed the initial investigation and turned the case over to the Detective Division for follow-up.
