

BLOTTER SUMMARY

September 12 through September 18, 2022

The Blotter reports below represent a selection of reports made between the dates above.

09/12/2022 8:32am The Police Desk was contacted by New York State Police personnel who had received a 911 hang-up with loud screaming in the background from a residence on Sarles Lane. Officers were dispatched as the Desk officer attempted to contact someone in the home. Upon arrival, officers learned that the family had called 911 for a child who had been choking, but whose airway was now cleared. The mother declined any further medical attention for the child.

09/12/2022 11:30am A village resident reported a man urinating on the side of the road with his buttocks and intimate parts exposed. The man was described as being in his 50's or 60's. Officers canvassed the area but the man was not located.

09/13/2022 12:19am The central station monitoring system for an alarm company reported a commercial burglar activation on Tompkins Avenue. Responding officers checked the ground level of the building and deemed it secure.

09/13/2022 1:20pm A resident of Sunnyside Avenue reported that a Paycheck Protection Program (PPP) loan had been taken out in his name in April of 2021. A report was filed and the case was turned over to the Detective Division for further investigation.

09/13/2022 3:45pm Sgt. Holly responded to Mount Pleasant PD HQ to assist with the search and detention of a female prisoner.

09/13/2022 9:26pm An employee of Liberty Lines reported a Bee Line Bus was involved in a motor vehicle accident on Bedford Road near the intersection with Pleasantville Road. Responding officers requested EMS for the driver of the car involved, who was injured when the airbag deployed. That party was transported to the hospital via a mutual aid ambulance, and his vehicle was towed from the scene. A NY State Accident Report was filed.

09/14/2022 8:25am An employee of a business on Marble Avenue reported the theft of two catalytic converters from company vehicles. The responding officer began the initial investigation, and learned that the crime occurred at some time in the past two weeks. A search for witnesses and cameras was done, and the case was turned over to the Detectives.

09/14/2022 2:20pm A woman came to Police HQ to report water leaking from the ground near the corner of Manville Road and Wheeler Avenue. The desk officer contacted DPW, who stated they were aware of the problem and working on remediation.

Responding officers found her responsive, and determined that the woman had failed to utilize the crosswalk and walked into a car which was proceeding westbound on Bedford Road. An ambulance and the paramedic responded, but the pedestrian refused further medical attention. A NYS Accident Report was filed.

09/15/2022 7:22am A resident of the Village called to request assistance for his father, who lives on Clinton Street, and was having chest pains. The ambulance and the paramedic were dispatched, and officers provided oxygen pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

09/15/2022 9:39am A resident of Washington Avenue requested assistance for his mother, who was feeling dizzy. When officers arrived, she also reported pain throughout her body. EMS was dispatched, and officers attempted to keep the woman comfortable pending their arrival. The patient was transported to the hospital by Pleasantville VAC.

09/15/2022 11:03am A resident of the Village reported a fox in her yard that was acting strangely. As the officers approached the animal, it popped up and fled into the woods through a neighbor's yard. The fox did not appear unhealthy, and officers believe it was just enjoying the sunshine. The fox had no contact with animals or humans in the area.

09/15/2022 12:02pm A Village resident reported she just saw a man urinating on Holy Innocents Church, and that the man was currently sitting on a bench in the area. The bench was clear upon their arrival, but officers located the man, a resident of Washington Avenue, a few blocks away. The man denied the allegations and left without further incident.
