September 19 through September 25, 2022

The Blotter reports below represent a selection of reports made between the dates above.

09/19/2022 7:11am A young man called the Police Desk to request assistance for his brother, who was conscious but dazed after a fall from a bench on Broadway. Officers determined the man had had a seizure, and they kept him comfortable and safe while awaiting the arrival of EMS personnel. The patient was transported to the hospital via Pleasantville VAC.

09/19/2022 1:34pm A mother reported that her teenage daughter had left their residence after a verbal dispute. Responding officers gathered a description and canvassed the area. The young woman was located a short distance away and returned home without further incident.

09/19/2022 3:06pm A resident of Mohegan Lake dialed 911 to report that he was feeling light-headed and has pulled over to the side of the road on Romer Avenue. Officers assisted him while awaiting the arrival of the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.
