

## **BLOTTER SUMMARY**

**September 26 through October 2, 2022**

The Blotter reports below represent a selection of reports made between the dates above.

09/26/2022 8:05am County Fire Control reported a carbon monoxide alarm activation at a business on Bedford Road. Officers found that the business was locked, and when a key holder could not be contacted, made entry with Fire Department personnel. The Building Inspector was requested to respond, and eventually the scene was deemed safe by FD personnel.

09/26/2022 11:57am A resident of Foxwood Drive requested an ambulance for their mother, who was experiencing pain and unable to walk. The responding officers provided medical assistance until EMS personnel arrived on scene. The patient was taken to the hospital by Pleasantville VAC for further treatment.

09/26/2022 3:35pm A resident of White Plains reported that there was a man on the Pleasantville Train Station platform acting strangely. The man was displaying money to people and asking people if they wanted to fight him. The man was observed on security cameras leaving the area towards Wheeler Avenue. The responding officers searched the area surrounding the train station, and the greater Downtown area for the man with negative results.

09/26/2022 6:44pm A resident of Foxwood Condominiums reported a loose dog in the area. The responding officer located the animal but identified it as an injured coyote. Upon the officer's approach, the animal quickly retreated into the woods without further incident.

09/27/2022 2:51am Mount Pleasant Police requested assistance in locating two youths who had run away from a local residential facility. Officers located the youths on Broadway and returned them to school staff.

09/27/2022 7:44am A resident on Eastview Drive called to report two loose dogs on Bedford Road. The responding officers advised they were able to reunite one dog with the

owner at the scene, and the second dog was located a short time later on Manville Road and returned to the owner.

09/27/2022 12:28pm Multiple 911 calls were received reporting a child with his head stuck in the sandbox at Roselle Park. The child had attempted to climb into a hole that was dug under the retaining railroad ties and got stuck. The child was safely freed prior to police arrival, so responding officers rendered assistance to the child and a medic evaluated him on scene. The child was unharmed. An officer was able to fill in the hole and the DPW and Recreation Department were notified to fully rectify the situation.

09/27/2022 5:16pm A resident of Meadow Lane requested assistance for his relative, who was highly intoxicated and unable to move. The responding officers provided medical assistance until EMS arrived. The officers assisted in escorting the male out of the house and into the ambulance. The patient was transported to the hospital by Pleasantville VAC.

09/27/2022 5:24pm A resident of Pleasantville Road who was travelling on Broadway reported two dirt bikes doing wheelies in that area. Responding officers found that the bikes were gone upon their arrival.

09/28/2022 10:17am A resident of Pleasant Avenue reporting the theft of tools from a residence that is undergoing renovations. The responding officer determined that a burglary had occurred, and a Detective was requested to respond to process the scene for evidence. The investigation is ongoing.

09/28/2022 2:02pm A resident of Stephen Drive called to report that she was near the intersection of Bedford Road and Broadway in the Old Village with an elderly woman who appeared confused. Responding officers determined the woman's identity and address and returned her home safely.

09/28/2022 4:42pm A resident on Broadway reported his mother unresponsive in their home. Upon arrival, the officers discovered the woman had regained consciousness and was awake and alert. Officers administered oxygen to her while the paramedic and ambulance responded. The patient was transported to the hospital by Pleasantville VAC for further treatment.

09/28/2022 5:26pm A resident of Hopper Street reported cars improperly parked near Parkway Field. Six summonses were issued.

09/28/2022 7:56pm A resident on Lenox Avenue requested medical assistance for her adult son who was complaining of a low heart rate. The responding officers provided medical assistance while awaiting the arrival of EMS personnel. The patient was transported to the hospital by Pleasantville VAC.

09/28/2022 8:42pm Mount Pleasant Police reported a disturbance on Broadway in the area of the Village line. Upon responding, officers found a young woman who was combative and expressing thoughts of self-harm. The woman was secured and transported to the hospital via a mutual aid ambulance.

09/29/2022 2:10pm A village resident reported that he was the target of a potential check fraud incident. The complainant stated that he listed a car for sale on Craig's List for \$4,500.00. He was contacted by a potential buyer, who sent him a check for \$8,900.00 and told him to return the difference. Instead, he reported the incident to the police, and was advised to cease all correspondence with the unknown party. The incident is currently under investigation.

09/29/2022 5:10pm A Thornwood resident contacted police requesting medical assistance for his friend, who resides on Lincoln Avenue and was having difficulty breathing. The responding officers provided oxygen until EMS arrived. The patient was transported to the hospital by Pleasantville VAC for treatment.

09/30/2022 3:33am A resident of Clinton Street called 911 to request an ambulance for herself due to extreme abdominal pain. The responding officers provided medical assistance pending the arrival of EMS personnel. The patient was transported to the hospital by Pleasantville VAC for further treatment.

09/30/2022 9:10am A resident of the Village reported a domestic dispute between himself and his adult son. The son had left the scene prior to the officer's arrival. The responding officers interviewed all parties on scene, and after the initial investigation was completed, officers determined that multiple crimes had been committed. A short time later, the son was placed under arrest and charged with Assault in the 3<sup>rd</sup> Degree and Criminal

Mischief in the 4<sup>th</sup> Degree. The son was processed and brought before a Village Justice for arraignment, and released. A temporary order of protection was issued.

09/30/2022 11:06am A resident of Martling Avenue requested an ambulance for her husband, who is COVID Positive and experiencing high blood pressure and an altered mental state. Officers followed COVID protocols and requested a medic and an ambulance be dispatched. The patient was transported to the hospital via Pleasantville VAC.

09/30/2022 7:57pm A resident of Guion Street reported loud music, possibly from a boom box, in the area of the Bedford Road School. Responding officers determined the noise was coming from a school-sanctioned event.

09/30/2022 8:50pm An anonymous caller reported a parking violation at the dead end of Hopper Street. The responding officer issued a summons.

10/01/2022 5:06am Despite conspicuous signage and postings, one car was impounded from the Memorial Plaza Lot for violation of the Farmer's Market parking restrictions.

10/01/2022 9:33pm County Fire Control reported they were dispatching Pleasantville Fire to a commercial fire alarm activation at a night time establishment on Bedford Road. Responding officers determined the alarm was set off by someone vaping in the bathroom.

10/01/2022 11:13pm A caller reported loud music in the area of her home on Mountain Road. Units canvassed the surrounding area but could not detect any loud music.

10/01/2022 11:59pm A clerk at a retail business on Bedford Road reported three youths had entered and left without paying for merchandise. Upon arrival, it was determined that the youths had been confronted by the store owner prior to leaving, and they had left the items in question behind. Patrol canvassed the surrounding area, but were unable to locate the parties in question.

10/02/2022 7:49am A local resident reported an open door at a restaurant on Bedford Road. Responding officers located an employee working inside.

10/02/2022 9:22am Multiple callers reported a large branch across the roadway of Bedford Road between Manville Road and Locust Road. The branch was in the jurisdiction of the town of Mount Pleasant, but Pleasantville officers assisted MPPD to block both directions of travel while the Mount Pleasant DPW safely removed the branch. The roadway was reopened to traffic in both directions within 30 minutes.

10/02/2022 8:35pm A resident of Parkway Terrace reported a possible bridge strike by a vehicle on the Saw Mill River Parkway. The responding officer confirmed that a truck struck an overpass, and Westchester County Police were notified.
