**3/28/2022 through 4/3/2022**

The Blotter reports below represent a selection of reports made between the dates above.

03/28/2022 2:14am A central monitoring station called the Police Desk to report a commercial alarm activation at a business on Clinton Street. Officers checked the business but found no sign of anything amiss.

03/28/2022 7:16am County Fire Control reported a residential fire alarm at a residence on Ashland Avenue. Patrol Officers assisted Fire Department members in determining the alarm was false.

03/29/2022 12:29am One of the owners called to report that while attempting to park in the private parking lot behind a residence on Saratoga Avenue, a driver had struck multiple parked cars. Officers responded and determined there was no criminality. A NYS Accident Report was filed.

03/29/2022 7:24am A resident of Foxwood Condominiums called to report her elderly mother was not feeling well and needed transport to the hospital. Responding officers kept her comfortable while awaiting the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

Pleasantville Fire Department was requested via County Fire Control. The residence was in fact located in the jurisdiction of the Mount Pleasant Police, who were notified. An investigation found there to be no carbon monoxide and that the alarm was false.

03/31/2022 12:07pm An alarm company reported a burglar alarm activation at a residence on Greenmeadow Road. Responding officers found an open door and conducted a walk-through of the residence, but found no signs of suspicious activity. The alarm company was asked to advise the homeowners and the house was re-secured.

03/31/2022 4:02pm The parent of a Pleasantville High School student who drives to school reported that she was advised by school personnel that her daughter's car was struck by another vehicle while parked during the school day. The other driver was contacted for information regarding the incident. A NY State Accident report was filed.

refusing to leave. Responding officers spoke to the newly-arrived man, who stated he was angry with the homeowner. Although agitated, officers did not assess him to be an immediate threat to himself or others. The traveler left the residence in a taxicab without further issue and was advised criminal charges would be filed for trespass if he returns.

04/01/2022 4:38pm The central station monitoring system reported a commercial burglar alarm activation at a business on Clinton Street. Responding officers checked the exterior of the building and found it secure on the ground level.

04/01/2022 7:30pm The central station monitoring system reported a commercial burglar alarm at a business on Pleasantville Road emanating from the employee door. Responding officers checked the exterior of the business and found it to be secure.

04/01/2022 7:36pm A resident of Pleasant Ave reported loud construction machinery noise in the area. Responding officers located the source of the noise as workers at a house in the area, who were requested to discontinue their work.

04/01/2022 11:45pm Following multiple 911 calls of a multi-vehicle accident on Bedford Road, officers responded and discovered that a vehicle parked and occupied on the side of the road was struck by a vehicle from behind in the area of the Old Village. The force of the impact then pushed the parked vehicle into the vehicle parked in front of it. The impact of the collision caused injuries to the person sitting in the parked vehicle. The driver responsible left the scene. Pieces of a black Tesla were left at the scene, and the investigation determined that such a vehicle, owned by a party out of Pleasantville, had been driving on Bedford Road at the time of the accident. Officers responded to that residence and noted the Tesla had extensive front end damage, but they received no answer when they attempted to contact anyone inside. The investigation is continuing.

04/02/2022 5:00am Despite being posted and noticed via multiple methods, two (2) vehicles were impounded from Memorial Plaza for the relocated Farmer's Market.

04/02/2022 6:31am A vehicle with a commercial registration was issued a summons for overnight parking on Manville Road.
