BLOTTER SUMMARY

March 13 through March 19, 2023

The Blotter reports below represent a selection of reports made between the dates above.

03/13/2023 5:38am Police and EMS assisted a resident complaining of pain in his lower extremity. Responding officers attempted to assist the man, but recognized the need for further medical interventions, and requested EMS response. The patient was transported via a mutual aid ambulance to the hospital.

03/13/2023 10:13am An employee of an estate company working at a residence on Guion Street requested the Police Department respond to take possession of three firearms found in the house. The officer who secured the firearms provided a receipt, and the weapons were placed in our evidence locker for storage until such time as a person authorized to do so could take possession.
