

BLOTTER SUMMARY

October 3 through October 9, 2022

The Blotter reports below represent a selection of reports made between the dates above.

10/03/2022 3:39am The owner of a business on Marble Avenue reported a “smash-and-grab” burglary. Multiple unknown parties had entered his store by breaking through the front door, stole merchandise and fled. Responding officers located three suspects who were placed under arrest and transported to HQ for processing. Detectives processed the scene. The suspects were processed and issued a court appearance date in the future.

10/03/2022 11:19am A new homeowner reported that upon purchasing a foreclosed home in the Village, they discovered that the previous owner had damaged several items in the home. The damage appeared to be intentional, and not normal wear and tear. The condition of the home was documented in a police report, and the owner was advised to follow up with the bank and their real estate lawyer.

10/03/2022 3:14pm A resident of Academy Street reported that she had lost her wallet which contained her NY State driver license and other personal papers. The officer advised her to cancel all lost credit cards and monitor her credit for any unauthorized charges. She was issued a form necessary to attain a duplicate license from DMV.

10/04/2022 1:57am A resident of Clinton Street reported that two unknown males had just attempted to steal her vehicle while it was parked in her driveway. The caller stated that when she went outside to confront the males, they fled the scene on foot. Responding officers, with the assistance of Mount Pleasant PD officers, canvassed the area and located a large group of youths at the Pleasantville train station. The caller was unable to positively identify any of the youths as the suspects. The investigation is ongoing.

10/04/2022 8:45am A witness reported a hit-and-run property damage auto accident on Saratoga Avenue, and provided a photo of the license plate of the car that left the scene. When contacted by officers, the owner of the car admitted he was driving the car at the time of the accident, but could not stop because he was late for an appointment. A NY State Accident Report was filed and the driver was issued a summons for Leaving the Scene of an Accident.

10/04/2022 12:03pm A bank on Washington Avenue called to report a verbal dispute in the branch between a man and his adult son. The responding officers spoke with both parties, who were arguing over the amount of money that the father would provide to his son. Officers were able to resolve the situation. Both parties left the scene without further incident.

10/04/2022 3:06pm Staff at the Pleasantville Middle School reported a larceny that occurred at the school on Saturday 10/1/2022 during the Rotary pancake breakfast. After some of the proceeds were discovered to be missing, video was checked and a man could be seen taking a money bag from the breakfast. Officers were able to identify the suspect, and they secured depositions and video evidence for the continuing investigation.

10/04/2022 8:05pm County Fire control requested an EMS response to a residence on Guion Street for a man not feeling well. Responding officers kept the man comfortable while Pleasantville VAC and the paramedic responded to the scene. The patient was transported to the hospital for further medical treatment.

10/05/2022 11:33am A resident of the Village requested medical assistance for her husband, who had fallen from the attic the day before. Upon the arrival of EMS personnel, officers assisted in getting him onto the stretcher and into the ambulance. He was transported to the hospital by Pleasantville VAC.

10/05/2022 1:57pm A village employee reported that she had been informed of a possibly sick coyote in an identified yard on Pierce Drive. However, when officers arrived, the coyote ran off into the woods.

10/05/2022 2:26pm A resident of Nannahagen Road reported a fire on the golf course of the Pleasantville Country Club. Officers on scene confirmed the fire was from an electrical box. Pleasantville Fire was dispatched via County Fire Control. Officers secured the scene while the fire department extinguished the fire.

10/05/2022 6:19pm A Village resident made a report of a college classmate securing access to one of his social media accounts. After the complainant realized he was locked out of his account, the suspect offered to release it back to him for a cash payment. The investigation is ongoing.

However, when another call about noise was received a short time later, officers requested the noise be silenced. Again, the party complied, this time for good.
