The Blotter reports below represent a selection of reports made between the dates above.

10/10/2022 2:54am A resident on Cedar Lane called requesting medical assistance for her husband, who she believed was having a seizure. The responding officers provided medical aid until EMS arrival. The husband was transported to the hospital by Pleasantville VAC.
