## **BLOTTER SUMMARY**

## October 17 through October 23, 2022

The Blotter reports below represent a selection of reports made between the dates above.

10/17/2022 12:59pm A resident of Iroquois Road reported a raccoon which appeared sick in the area of Lake Street near the intersection with Broadway.
