

BLOTTER SUMMARY

October 24 through October 30, 2022

The Blotter reports below represent a selection of reports made between the dates above.

10/24/2022 8:23am A resident of the Clinton Street Center requested medical assistance and transport to the hospital. The responding officer found the aided party in discomfort, and remained with her until EMS arrived. The patient was transported to the hospital for further evaluation by Pleasantville VAC.

10/24/2022 1:47pm A village resident reported offensive graffiti on the Sunnyside Avenue railroad bridge. The responding officer took photos of the graffiti to document the incident, and the MTA Police were notified since the bridge is within their jurisdiction.

10/24/2022 3:01pm A young woman from the Bronx walked into Police HQ requesting assistance because she was feeling suicidal. Officers remained with her and built rapport while the Desk Officer requested the Mobile Crisis Response Team to respond. The woman was transported to the hospital via a mutual aid ambulance.

10/24/2022 4:52pm A resident of Willow Street reported a raccoon that appeared sick on his property. Responding officers located the animal, but discovered it was not sick, only stuck in a window well. The raccoon was safely exfiltrated by the officers, and was last seen relocating to the woods.

10/24/2022 11:30pm Staff members of a residential treatment facility reported that one of their students had climbed onto the train tracks at the Pleasantville train station, and was walking south on the north bound tracks. MTA Police were notified regarding the incident, and Pleasantville officers remained on scene with school staff and provided assistance to MTA officers.

10/25/2022 8:06am A village resident requested medical assistance for his wife, who was unresponsive but breathing. The ambulance and paramedic were dispatched, and responding officers provided medical assistance until EMS personnel arrived. The patient was transported to the hospital by Pleasantville VAC.

10/25/2022 5:25pm County Fire Control reported an automatic fire alarm activation at a business on Washington Avenue. Responding officers discovered that the alarm was set off in error, and the scene was cleared by Pleasantville FD.

10/25/2022 8:49pm A resident of Foxwood Drive reported that she had fallen and requested assistance getting up. Upon arrival, officers discovered that the caller had sustained an injury, and EMS was requested to respond the scene. The caller was transported to the hospital by Pleasantville VAC for further medical treatment.

10/26/2022 12:12am The owner of a property on Bedford Road reported a carbon monoxide alarm activation. The responding officers assisted in determining that the alarm was set off due to a malfunction in the detector. The scene was cleared by Pleasantville FD.

The responding officers assisted Pleasantville Fire Department personnel to determine that the alarm was set off due to a malfunction in the system. The all clear was given by the Fire Department.

The ambulance and paramedic were dispatched, and the responding officers provided medical assistance until EMS arrived. The patient was transported to the hospital by Pleasantville VAC.

After interviewing all the parties involved, the responding officers discovered that there was a verbal dispute between the resident and a worker at a neighboring unit over the noise level from the work being performed. Since no crime had been committed, the officers advised both parties to separate, and they agreed to avoid contact with each other.

10/28/2022 2:57pm A young woman who lives in Brewster reported an injured squirrel on Marble Avenue, near Hopper Street. Upon arrival, the officer determined that the squirrel was deceased. DPW personnel were requested to respond to remove it from the road.

Con Edison was contacted to repair the damaged utility pole, and the roadway was intermittently closed until the pole could be made safe.
