

BLOTTER SUMMARY

October 31 through November 6, 2022

The Blotter reports below represent a selection of reports made between the dates above.

10/31/2022 9:31am A resident of Academy Street reported vehicles parked in violation on the street in front of his home. The responding officer was able to locate the owners and have them relocate their vehicles.

10/31/2022 2:20pm County Fire Control requested medical assistance for an unconscious party at a residence on Treetop Lane. Upon arrival, responding officers discovered that the person involved was awake and alert. The patient was transported to the hospital by Pleasantville VAC.

10/31/2022 7:55pm Mount Pleasant Police reported a fight in progress on Manville Road, near the Jacob Burns Film Center. Responding officers located the parties involved, who were merely juveniles spraying each other with shaving cream. All the parties involved were sent on their way.

10/31/2022 10:16pm A resident of Ashland Avenue reported a large group of youths on the turf field at Pleasantville Middle School. Responding officers located the group and checked the field for damage but found none. The youths were turned over to the custody of their parents.

11/01/2022 8:51am A resident on William Street called to report that her father wasn't feeling well due to COVID symptoms. The responding officers took precautions to prevent the spread of the disease during their time with the man. The patient was transported to the hospital for further evaluation by Pleasantville VAC.

11/01/2022 2:47pm The crossing guard at the intersection of Manville Road and Academy Street reported a box truck had become stuck while making the turn up the hill of Academy Street. The responding officer managed traffic at the scene and requested a tow truck to pull the truck free. The tow truck was able to free the vehicle.

11/01/2022 8:50pm A resident of Mount Kisco requested a welfare check on her friend, who lives on Grandview Avenue. The caller stated that while they were in the middle of a telephone conversation, she suddenly lost contact, and could only hear groaning in the background. Responding officers located the woman outside the rear of the residence complaining of an injury from a fall. The officers requested EMS, and attempted to keep her comfortable pending their arrival. The officers assisted in carrying the female to the stretcher, and she was transported to the hospital via Pleasantville VAC.

11/01/2022 10:23pm A customer at a business on Marble Avenue requested police assistance for a dispute over services rendered. Upon speaking to both the customer and the employee involved, officers mitigated the dispute, which included the payment to replace a clock damaged during the initial interaction. The customer left the premise willingly after being advised he was no longer welcome at that establishment.

11/02/2022 12:47am A resident of Sky Top Drive requested a police walk-through of his house after his home alarm was activated. Responding officers checked the interior of the residence and found nothing amiss.

11/02/2022 1:00am Mount Pleasant Police requested our officers be on the lookout for a group of AWOL students who had left the campus of their residential facility and were walking on Broadway. The responding officers canvassed the immediate area, and located the group in the Pleasantville Middle School parking lot. The youths were turned over to staff without incident.

11/02/2022 9:15am Mount Pleasant Police reported a motorcyclist down on Broadway. Responding officers located the motorcyclist, a resident of Pleasantville, at the scene with a minor complaint of pain from the incident. He reported that as he was proceeding south, he noticed a construction vehicle too late to stop, and had to drop the bike to avoid an accident. The man refused medical attention, and a NY State Accident Report was filed.

11/02/2022 11:56am County Fire Control reported an automatic fire alarm activation at a residence on Bedford Road. Responding officers were able to determine that the alarm was set off in error due to construction work inside the residence.

11/02/2022 5:16pm A resident of Washington Avenue reported two men, who had been operating a white truck, opening a manhole cover near Edgewood Avenue. The responding officers determined that the men were plumbers doing work at a house on Washington Avenue.

11/03/2022 2:28am The central monitoring station for a private alarm company reported a glass break alarm at a residence on Sunnyside Avenue. The responding officers checked the exterior of the house, and everything appeared secure.

11/03/2022 11:35am A Life Alert activation was reported for a woman residing at the Clinton Street Center who was bleeding from the mouth. The responding officers provided medical assistance and requested the ambulance and the paramedic to respond. The patient was transported to the hospital by Pleasantville VAC.

11/03/2022 6:15pm A resident on Dennis Lane requested medical assistance for his wife, who had suffered injuries from a fall. The responding officers found the woman upright, but complaining of hip pain, so EMS was dispatched. She was transported to the hospital by Pleasantville VAC for further evaluation.

11/03/2022 9:54pm An employee of a business on Manville Road reported that a customer had passed out, and was currently unresponsive. Upon their arrival, the responding officers discovered that the woman in question, a resident of Yonkers, had regained consciousness. The paramedic and an ambulance were dispatched and the patient was transported to the hospital by Pleasantville VAC.

11/03/2022 11:25pm A resident of Washington Avenue requested medical assistance for severe pain in his back that developed while playing video games. The responding officers provided medical aid until EMS arrived, and the party was transported to the hospital by Pleasantville VAC.

11/04/2022 12:06pm A resident of Washington Avenue requested medical assistance for her friend, who was complaining of severe chest pains. The responding officers provided aid until EMS arrival, and the patient was transported to the hospital by Pleasantville VAC for further evaluation.

11/04/2022 5:52pm A resident of Willow Street reported two suspicious vehicles in front of his residence. One vehicle, described as a black sedan, pulled into his driveway, while the second vehicle, a white mini-van or SUV, stopped in the roadway. When approached by the homeowner, the vehicles left the area. An initial investigation was commenced, including the collection of video of the incident and a canvass of relevant locations.

11/04/2022 6:22pm A resident of Elm Street reported vehicles parked in violation near his home. The responding officer issued summonses to two vehicles.

11/05/2022 5:00am One vehicle was impounded from the Memorial Plaza Lot for parking in violation of postings for the Farmer's Market.

11/05/2022 11:26am The central monitoring station for a private alarm company reported an automatic alarm activation at a residence on Bedford Road. Responding officers were cancelled while in route to the home by the alarm company after receiving the proper security code from the homeowner at the residence.

11/05/2022 6:30pm An employee of Liberty Bus Lines reported that the driver of the bus stopped on Bedford Road had called in an unresponsive party on the bus. Officers responded, and the ambulance and paramedic were dispatched. Upon arrival, responding officers located the man, who was unconscious and barely breathing, and suspected an opioid overdose. The officers administered two doses of Naloxone ("Narcan"), and a third dose was administered by the responding paramedic. The aided party, a resident of Yonkers, regained consciousness after the third dose, and was transported to the hospital by Pleasantville VAC for further treatment.

11/06/2022 12:22am An employee of a business on Marble Avenue reported three men wearing ski masks looking at vehicles in a restaurant parking lot. The responding officer located three males that matched the reported description walking in the business district a short time later, and Mount Pleasant Police were requested for additional assistance. The males were identified as residents of a local educational facility, and since no crimes were committed, they were transported back to campus to the custody of staff.

11/06/2022 9:28am A resident of Cooley Street reported noise from construction work being done at neighbor's house, in violation of village ordinance. The responding officer interviewed the workers on scene, who stated that they were attaching tarps to the roof in preparation for impending rain. The officer allowed them to continue, as emergency work is permitted.

11/06/2022 7:13pm County Fire Control reported they were dispatching the Pleasantville Fire Department to a residence on Ashland Avenue for a carbon monoxide alarm activation. The responding officers reported that the alarm was the result of a malfunction, and the scene was cleared by Pleasantville FD.

11/06/2022 9:41pm A resident of Clinton Street requested assistance after she fell and was not able to get up on her own. The responding officers reported the party was assisted up, but then refused any further medical attention.
