## **BLOTTER SUMMARY**

## November 7 through November 13, 2022

The Blotter reports below represent a selection of reports made between the dates above.

11/07/2022 4:14am The central station monitoring system for an alarm company reported an automatic alarm activation in the library of Bedford Road School. The responding officers checked the premise, and the school was secure.

11/07/2022 7:04am A local resident reported a raccoon with a large can stuck on its head in the area of Grant Street. Officers checked the area, but the animal was not located, and no further calls were received regarding the raccoon.

11/07/2022 9:24am Mount Pleasant Police requested Pleasantville VAC respond to Marble Avenue near the town line for a party having difficulty emotionally regulating themselves. Due to the location of the call, Sgt Holly assisted in securing the scene and getting the individual involved a mental health evaluation.

The responding officers tended to the woman until the paramedic and the ambulance arrived. The patient was transported to the hospital via Pleasantville VAC.

The man was evaluated, deemed to be in good health, and refused any further medical interventions.

11/08/2022 9:04am A man from Brewster reported that his car was out of gas and blocking the roadway on Grant Street. The responding officer assisted in pushing the vehicle out of the lane of traffic and the driver was given a courtesy transport to a gas station.

He was transported to Pleasantville HQ, processed and released on his own recognizance. The vehicle was impounded, and NYPD was notified regarding the recovery of the vehicle.

11/10/2022 11:19am The central monitoring station for an alarm company reported an alarm activation at a residence on Tompkins Avenue. Responding officers checked the exterior of the home and found no signs of anything amiss.
