

## **BLOTTER SUMMARY**

**November 14 through November 20, 2022**

The Blotter reports below represent a selection of reports made between the dates above.

11/14/2022 2:07am The central monitoring station for an alarm company reported an automatic burglar alarm at a business on Clinton Street. The responding officers checked the exterior of the building and deemed it secure.

11/14/2022 11:01am A resident of Washington Avenue reported seeing a coyote roaming around his property. The responding officers checked the area but the animal had returned to the woods prior to their arrival.

11/14/2022 5:35pm A medical alert company reported a pendant activation by a resident on Hopper Street with no answer on their call back. The responding officers were able to gain entry to the residence, and located an elderly female on the floor who was disoriented with unknown injuries. The ambulance and the paramedic were dispatched, and officers provided medical assistance until EMS arrived. The party was transported to a local hospital by Pleasantville VAC for further treatment.

11/14/2022 8:05pm A resident of White Plains reported a vehicle with multiple propane tanks inside parked in the Memorial Plaza Lot. The investigation determined that the tanks were being transported by the manager of a local business for legitimate purposes. The owner of the vehicle was advised of the danger of transporting multiple tanks in this manner.

11/14/2022 8:49pm A resident on Grandview Avenue reported that a fuse had blown in her breaker panel, and when she went to check she could smell and see smoke. Pleasantville Fire was dispatched, and responding officers assisted the investigation for the scene to be cleared by Pleasantville FD.

11/15/2022 5:25am An alarm company reported an automatic burglar alarm at a commercial location on Pleasantville Road. The responding officers completed a check of the premises, and everything appeared secure.

11/15/2022 11:25am A resident of Madison Avenue requested assistance, as she had fallen, and could was unable to get up on her own. Officers assisted the woman up and assessed that she had not sustained any injuries.

11/15/2022 4:33pm A medical alert company reported an elderly resident of the Clinton Street Center had fallen and needed assistance getting up. The responding officers were able to assist the party with getting back upright. No injuries reported and no other assistance was requested.

11/15/2022 8:48pm Mount Pleasant Police requested assistance in following up on a domestic dispute that occurred in their jurisdiction, involving a complainant who lives on Hopper Street. The woman was unable to respond to the Mount Pleasant HQ to file the report due to issues with her ex-spouse. Officers responded to Hopper Street to remain with the complainant until Mount Pleasant officers could arrive at the residence to complete the investigation.

11/16/2022 7:07am A Pleasantville resident called 911 to report that he had been involved in a motor vehicle accident with injuries at the intersection of Marble Avenue and Castelton Street. The responding officers managed traffic and provided medical attention to the injured party until EMS arrived. The driver of one of the vehicles involved was transported to the hospital by Pleasantville VAC, and a NY State Accident report was completed.

11/16/2022 11:18am A resident of Saratoga Avenue reported that while backing out of his driveway, he had struck an unoccupied vehicle parked across the street. A NY State Accident report was filed.

11/16/2022 2:35pm A Pleasantville resident came to Police HQ to surrender firearms as per a Temporary Order of Protection issued by Rye City Court. The Detective took the firearms into custody, provided a receipt to the owner and secured them for safekeeping.

11/17/2022 9:08am A resident of the Clinton Street Center requested assistance, as she could not get out of bed on her own. The responding officers assisted the woman in getting up.

11/17/2022 9:53am A resident of Seneca Lane reported that her neighbor was taking photos of her property and yelling profanities. The responding officers discovered this was an ongoing neighbor dispute in regards to alleged tenants at one neighbor's house. Both parties

were advised to avoid each other, and to contact the police for any further issues. The incident was referred to the Building Department for follow up.

11/17/2022 9:46pm Mount Pleasant Police Dispatch reported a property damage auto accident in the past on Cooley Street. The responding officer learned that earlier in the day, a parked and unoccupied vehicle that was in the lot for 75 Cooley Street was struck by an unknown vehicle, which left the scene. The officer began an investigation of the incident, and came to identify the driver of the other vehicle involved. A summons for leaving the scene of a property damage auto accident was issued, and a NYS Accident Report was filed.

11/18/2022 1:01am County Fire Control reported a resident of Seneca Lane feeling dizzy. Upon arrival, the officers provided first aid while an ambulance and paramedic were dispatched, and the woman's condition improved to where she eventually refused further medical attention.

11/18/2022 7:59am A passerby reported a man hunched over in the roadway at the intersection of Manville Road and Washington Avenue. The ambulance and the paramedic were dispatched. Responding officers located the man and determined he appeared to be suffering from a negative reaction to drugs. The officers assisted the man from the roadway, and provided medical assistance until EMS arrived. The patient was transported to the hospital by Pleasantville VAC for further treatment, and the Mobile Crisis Response Team was advised of the situation so they could follow up with the man.

11/18/2022 11:45am A woman at a business on Marble Avenue called 911 to request medical assistance for an employee who was suffering from an asthma attack, and was now unconscious. EMS personnel were dispatched, and the responding officers provided medical aid until they arrived. The patient was transported to the hospital by Pleasantville VAC.

11/18/2022 1:24pm A witness reported a minor auto accident at the intersection of Tompkins Avenue and Clinton Street. The responding officer confirmed that no one was injured and compiled the necessary paperwork to document the incident. A NY State Accident Report was filed.

11/18/2022 8:22pm A call was received from County Fire Control reporting a party feeling dizzy on a Metro North Train at the Pleasantville Train Station. The responding officers assisted MTA Police who were on scene to handle the call. The paramedic and the ambulance were dispatched. The patient was transported to the hospital by Pleasantville VAC.

11/19/2022 9:25am Multiple calls were received reporting a vehicle accident with airbag deployment on the Saw Mill River Parkway at the intersection with Grant Street. The responding officers secured the scene until Westchester County Police arrived. EMS personnel were dispatched to assist and transport injured parties to the hospital.

11/19/2022 1:15pm A 911 hang up was received from a business on Pleasantville Road. After the Desk Officer attempted to call the number back multiple times but got no response, officers were dispatched. Upon his arrival, the responding officer reported that 911 had been dialed in error by an employee. No issues reported.

11/19/2022 1:34pm The Director of the Pleasantville Farmer's Market turned in a found I-Phone to the police department. Approximately an hour later, a family member of the owner called the phone, and they were advised of its location. The owner then responded to the police station and was reunited with her lost phone.

11/19/2022 4:17pm A resident reported an inside odor of gas in their home on Great Oak Lane. Con Edison and Pleasantville FD were dispatched. The responding officers confirmed odor inside the residence. The house was cleared of any gas leak, but the homeowner was advised to contact a plumber, as it appeared the trap from one of the sewer lines may have been cracked or broken, causing odor to back up into home.

11/19/2022 5:11pm County Fire Control requested EMS for a man on Guion Street experiencing a medical emergency. The responding officers provided medical attention until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

11/19/2022 6:47pm A resident of Gregory Place reported seeing a coyote running in the street. The responding officer canvassed the area with negative results.

11/19/2022 8:20pm A resident of the Clinton Street Center called to report that she had fallen, and could not get up on her own. The responding officers assisted in getting her upright, and no injuries were reported.

11/20/2022 12:12pm An alarm company reported an automatic alarm at a residence on Dennis Lane. The responding officers advised checking the exterior of the residence, and the ground floor appeared secure.

11/20/2022 3:09pm A passerby came into Police HQ to report an alarm siren coming from a business on Bedford Road. The responding officer found the front door unlocked and searched the interior of the business, where everything appeared to be in order. A key holder for the building was requested to respond to the business to re-secure the front door.

11/20/2022 4:11pm A resident of the Bronx called 911 to request EMS because he claimed he wanted to harm himself, and gave his location as near the intersection of Bedford Road and Pleasantville Road. Responding officers were able to locate the man on Cooley Street in a highly agitated state; repeatedly yelling at the officers to shoot him, while placing a hand into his waist band. The officers acted quickly to restrain the party for his safety until the ambulance and the paramedic could arrive for evaluation and transport. The man was transported to the hospital by Pleasantville VAC with an officer on board.
