

## **BLOTTER SUMMARY**

**November 21 through November 27, 2022**

The Blotter reports below represent a selection of reports made between the dates above.

11/21/2022 3:05am While on routine patrol, Officer Cole-Hatchard noticed that a spotlight outside the Recreation department was malfunctioning. A voice mail was left for the recreation superintendent.

11/21/2022 3:43pm A resident of Sutton Place reported an outside water condition. Responding officers confirmed the issue, and the Water Department was notified to respond.

11/21/2022 6:03pm A resident of Foxwood Condominiums requested a welfare check on a Village resident after she became aware that the woman might be in emotional distress. Responding officers interviewed the woman and determined she was not in need of further interventions.

12/21/2022 6:28pm A resident of Iroquois Road reported an inside odor of gas at her residence. The woman further reported the stove was malfunctioning. Officers assisted Pleasantville Fire to make the scene safe and address the problem.

11/22/2022 2:59pm A resident reported several vehicles parked in violation on Sutton Place. Upon the officer's arrival, the vehicles in question had been moved.

11/22/2022 3:24pm A healthcare monitoring system requested assistance for a resident of the Clinton Street Center who was ill and unable to move. Officers assisted the woman while awaiting the arrival of the paramedic and a mutual aid ambulance. The patient was transported via a mutual aid ambulance to the hospital.

11/22/2022 5:30pm An ambulance was requested on Manville Road for a party who was unable to ambulate. Officers kept the man comfortable while awaiting the arrival of EMS. The patient was transported to the hospital via Pleasantville VAC.

11/23/2022 9:39am The Pleasantville Parks foreman reported graffiti on a village flower pot in front of a restaurant on Bedford Road. Responding officers documented the incident, and the graffiti was then removed by Village employees. The investigation is continuing.

11/23/2022 5:26pm An elderly resident of Foxwood Condominiums called to report she was having a disagreement with her home health aide. The responding officers spoke to the woman's daughter via telephone and learned that the caller was suffering from dementia and there were no wellness concerns. Officers assisted the woman to feel comfortable that she was safe at home in the care of her aide.

11/23/2022 7:47pm A resident of Foxwood Condominiums called 911 and then hung up without speaking. Multiple calls were placed back to the caller with no response. Upon arriving at the residence, officers were able to speak to the caller and determined she had dialed 911 in error.

11/23/2022 11:36pm A resident of Great Oak Lane reported that his house had just been egged by unknown persons running through his backyard. Responding officers checked the area but the parties responsible were gone upon their arrival.

11/24/2022 4:57am A resident of Dennis Lane called to report that an intoxicated stranger had attempted to enter his home without permission and was attempting to leave in an Uber. Officers responded and interviewed several people on scene and determined that the unknown man was a "friend of a friend of a friend" that had been invited (unbeknownst to the other residents) to return to the home after a night of partying. All parties involved were identified by responding officers and sent on their way.

11/24/2022 9:54am County Fire Control reported an activated fire alarm at a restaurant on Marble Avenue. Pleasantville FD was dispatched, and responding officers determined that the condition had been caused by cooking.

11/24/2022 1:29pm A Lake Street resident reported a party with a head injury from a fall down the stairs at the Pleasantville Country Club. Officers and the paramedic responded, and the injured party was transported to the hospital by a mutual aid ambulance for further treatment.

11/24/2022 3:18pm A resident of Sarles Lane reported a man down on Mountain Road. Officers responded and provided assistance to the man, who lived in the area and was intoxicated. Mount Pleasant PD responded and took control of the scene, as the call was in their jurisdiction.

11/25/2022 4:51am Mount Pleasant PD requested assistance in locating the driver of a vehicle involved in a motor vehicle accident on the Saw Mill Parkway who had fled the scene on foot. After a Pleasantville FD Chief observed the party in an alley adjacent to Marble Avenue, he was detained by responding officers until County Police personnel could respond and issue a summons.

11/25/2022 7:23am The central station monitoring system for an alarm company reported an activated residential burglar alarm on Weskora Avenue. Responding officers checked the premise, which was secure.

11/25/2022 9:10am A resident of Washington Avenue reported a large bird in her backyard for the past 24 hours that seemingly refused to fly away. Responding officers deemed the bird was a wild turkey, and no further action needed to be taken, as turkey was in its natural habitat.

11/25/2022 10:53am A resident of Great Oak Lane reported his house had been egged for the second night in a row. The cost for cleanup was estimated to be \$200. The responding officer gathered information and filed the case report to be followed up by the Detective Division.

11/26/2022 10:24am A resident of Clinton Street reported that he had locked his keys in his vehicle. The responding officer was able to gain access to the car's interior.

11/27/2022 2:52am A resident of Weskora Avenue reported her husband was suffering from a high fever. Responding officers observed COVID protocols and the ambulance and the paramedic were dispatched. The patient was transported to the hospital via Pleasantville VAC.

11/27/2022 1:12pm A resident of Meadow Lane reported several vehicles parked within 25 feet of the stop sign at the intersection of Saratoga Avenue and Meadow Lane, in violation of the NY State Vehicle and Traffic Law. Upon arrival, the responding officer determined that the closest vehicle to the intersection was at least 30 feet away, and therefore not in violation.
