BLOTTER SUMMARY

November 28 through December 4, 2022

The Blotter reports below represent a selection of reports made between the dates above.

11/28/2022 2:08pm The central monitoring station for a delicatessen on Wheeler Avenue reported a smoke / heat detector activation. Officers were dispatched, along with Pleasantville FD. When it was determined that the alarm had been set off by cooking, the scene was cleared.
