## **BLOTTER SUMMARY**

## 4/4/2022 through 4/10/2022

The Blotter reports below represent a selection of reports made between the dates above.

04/04/2022 8:15am This Department received a 911 hang-up from a residence at the Clinton Street Center. When the Desk Officer called back, no one answered, prompting him to dispatch officers to check out the status of the caller. Responding officers found the resident had dialed 911 in error.
