

## **BLOTTER SUMMARY**

**April 3 through April 9, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

04/03/2023 9:37am A resident of Tudor Court requested assistance getting into her vehicle after she accidentally locked the keys inside. The responding officer was able to make entry into the vehicle without issue.

04/03/2023 10:26am The Parking Enforcement Officer reported a person to whom she had issued a summons had become irate and may be following her. She provided a description of the man and his car. Officers located him operating the vehicle on Bedford Road. When interviewed, the man, a resident of Pleasantville, denied following the PEO and stated he had been yelling and cursing about the situation, not directly at the PEO. Officers advised him of options for disputing the summons if he chose to do so.
