## **BLOTTER SUMMARY**

## April 24 through April 30, 2023

The Blotter reports below represent a selection of reports made between the dates above.

04/24/2023 5:41am A resident of Guion Street requested EMS for her adult son, who had fallen while having a seizure. Responding officers provided medical assistance pending the arrival of the paramedic and the ambulance. The patient was transported to the hospital by Pleasantville VAC.
