

BLOTTER SUMMARY

December 12 through December 18, 2022

The Blotter reports below represent a selection of reports made between the dates above.

12/12/2022 8:54am The central monitoring station for an alarm company reported a residential burglar alarm at a residence on Manville Road. Officers checked the exterior of the building and found it secure on the ground level.

12/12/2022 5:00pm A resident of Washington Avenue walked into Police HQ and, although showing no injuries, seemed confused and unsure of her surroundings. The desk officer contacted the woman's daughter, who lives in Pound Ridge, who stated that she was not surprised of her mother's altered mental state. The daughter responded to HQ and the woman was released into her care.

12/13/2022 1:18am During a traffic stop on Pleasantville Road for failing to stop for a red light, the operator of the stopped vehicle fled at a high rate of speed eastbound on Bedford Road. Officers attempted to stop the vehicle, however, the officer lost sight of the vehicle and terminated any pursuit. Following this department's notification of surrounding agencies, the suspect was subsequently apprehended by Westchester County PD after a failure to comply the on the Sprain Brook Parkway. The driver, a 22-year-old man from the Bronx, was arrested at WCPD HQ and processed at Pleasantville PD HQ. He was charged with Unlawful Fleeing a Police Officer in the Third Degree and issued multiple traffic summonses, with a return date to Village Justice Court.

12/13/2022 11:21am A resident of Maple Hill Road reported an injured coyote on Bedford Road. Officers located the animal, who appeared injured but was not aggressive. The animal retreated into the woods before the officers could get close enough to assess the situation.

12/13/2022 12:40pm A resident of Academy Street reported a car parked in violation on Manville Road. One summons was issued.

12/13/2022 7:59pm A party walked into headquarters and reported an odor of gas in front of a business on Wheeler Avenue. Responding officers confirmed the odor and requested Pleasantville Fire and Con Edison to respond. PFD personnel determined the odor was coming from test holes previously drilled by Con Edison, and the scene was turned over to the utility company upon their arrival.

Responding officers found that a large tanker truck delivering gasoline struck and damaged the Village-owned property. No one was injured, and A NY State Accident Report was filed.

Upon officer's arrival, it was determined that the parties involved had originally exchanged information, but upon finding a discrepancy in the information, one party wished to have the incident officially documented.
