## **BLOTTER SUMMARY**

## December 26, 2022 through January 1, 2023

The Blotter reports below represent a selection of reports made between the dates above.

12/26/2022 9:53am A resident of Briarcliff reported his car had broken down in a lane of traffic on Pleasantville Road. A tow truck was dispatched, and officers responded to assist with traffic control. Upon their arrival, however, the vehicle started again, and the tow truck was cancelled.

12/26/2022 2:48pm Fire Control requested Fire, EMS and PD to a residence on Washington Avenue to assist a young child whose hand was stuck in a toy cutting off circulation. Upon arrival, officers worked with the paramedic to extricate the child's hand free of the toy. No further medical attention or services needed.

12/26/2022 10:53pm The central monitoring station for an alarm company reported an interior motion detection at a business on Marble Avenue. Responding officers came upon the owner of the business as he was leaving. The building was secure, as the owner had set off the alarm in error.

Officers responded to the home and interviewed the man, who began to make threats to harm himself. EMS was dispatched, and the patient was transported to the hospital for a mental health evaluation. A NY State Domestic Incident Report was filed, and the caller received follow-up on her options going forward.

12/29/2022 1:15am A resident of Sarles Lane reported a large fire and smoke condition on the track of the northbound train. Responding officers confirmed a fire burning on Track 2 under the Manville Road overpass. MTA PD was notified, and traffic and power on the lines were terminated. Pleasantville FD responded, but the fire had burned itself out. The cause was suspected to be salt brine from the roadway above getting on the heating element. 12/29/2022 7:29am A Pleasantville Water Department employee reported unauthorized use of the fire hydrant at the intersection of Bedford Road and Orchard Street. Responding officers interviewed the two men on scene, who stated they were attempting to use the water to thaw a tank they need for work to a residence on Orchard Street. Both men were identified and advised they were not to use fire hydrants for their own purposes.

A vehicle operated by a resident of Valhalla struck the vehicle in front of it while awaiting the traffic light to change. No injuries were sustained, and a NY State Accident Report was filed.
