

## **BLOTTER SUMMARY**

**January 2 through January 8, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

01/02/2023 2:08am A resident on Pleasant Avenue requested medical assistance for her husband, who was COVID positive and having difficulty breathing. The responding officers provided medical assistance until EMS arrived, and the patient was transported to the hospital by Pleasantville VAC.

01/02/2023 3:30pm Following a traffic stop on Bedford Road for an expired inspection, the driver of the vehicle, a 21-year-old resident of the Bronx, was found to be operating the vehicle without insurance or a valid registration. Multiple summonses were issued and the vehicle was impounded from the scene.

01/02/2023 5:08pm A 911 hang up call was received from a resident on Clinton Avenue, with no answer on the call back. The responding officer was able to make contact with the resident, and discovered that, despite a language barrier, the resident had called 911 in error, and no assistance was needed.

01/03/2023 7:13pm The central monitoring station for an alarm company reported an automatic alarm at a location on Marble Avenue. The responding officer determined that the alarm was set off in error by a cleaning crew.

01/03/2023 7:58pm A resident of Greenmeadow Road requested assistance for her husband, who had briefly passed out but had since regained consciousness. Responding officers assisted with first aid until the arrival of EMS personnel, who evaluated the man. Following that, he refused further medical attention.

01/04/2023 11:46am A resident of Brooklyn reported that she and another party were stuck in the elevator at the Pleasantville Metro North train station. Pleasantville FD and MTA PD were dispatched, and responding officers assisted at the scene. FD personnel were able to open the door and free the parties inside, and no injuries were reported.

01/04/2023 6:12pm A village resident reported an oil truck was spilling oil on Court Street. Upon their arrival, officers spoke to both the homeowner and the caller, but discovered that the oil truck had departed and no oil had been spilled.

01/04/2023 9:08pm A resident on New Street reported that an unknown party had thrown eggs at her house. The responding officers completed the initial investigation, and the incident was forwarded to the Detective Division for follow-up.

01/04/2023 11:09pm A resident of the Clinton Street Center reported that she had fallen and could not get up on her own. The responding officers determined she was not injured and assisted her upright.

01/05/2023 7:27am A resident of Robbins Road reported her mother was experiencing abdominal pain. The ambulance and the paramedic were dispatched, and responding officers provided assistance until EMS arrived. The patient was transported to a local hospital by Pleasantville VAC.

01/05/2023 10:52am A 911 call was received from a residence on Sunnyside Avenue, with no response on the other end. The desk officer attempted to call the number back, with no success. The responding officers spoke to the residents, who stated they did not make any 911 calls. While on scene, another 911 call was received from the same residence. It became apparent that there was a malfunction with the phone lines, and residents stated they would follow up with their service provider.

01/05/2023 2:43pm A detective from the Mount Pleasant Police Department reported that they had recovered several FedEx boxes that appeared to have been stolen from two drop box locations within the Village. The drop boxes are located at 427 Bedford Road, and 35 Irvington Street. An investigation into the incident is ongoing.

01/05/2023 3:12pm A possible domestic dispute was reported near the intersection of Marble Avenue and Bedford Road. Responding officers located and spoke with both parties. While the male was uncooperative, the female involved reported it was only a verbal argument between friends, and not a domestic dispute. The woman reported she was not fearful or in danger, and then went on her way.

01/05/2023 4:01pm A resident of Romer Avenue requested assistance for a friend who had locked her keys in her car. The responding officer was able to gain entry to the vehicle.

01/06/2023 9:06am One of the drivers involved reported a minor motor vehicle accident at the intersection of Saratoga Avenue and Garrigan Avenue. While turning in traffic, the vehicles collided, causing minor damage. The responding officers advised that all parties were uninjured, and both vehicles were able to be driven from location. A NY State Accident Report was filed.

01/06/2023 5:49pm An administrator at the Pleasantville High School reported a suspicious party in the gym lobby while a sporting event was going on. The party is known to the school administration for committing larcenies in the past, and the caller was concerned. Responding officers did not discover any crimes had been committed, but the man was advised to leave the premises and not return.

01/07/2023 12:33am A youth came into HQ to report they believed their two friends had been abducted in a van. Officers canvassed the area, and performed an extensive review of the village surveillance cameras. The investigation revealed that the "victims" had yelled to their friend as they left, seemingly playing a prank, and were never in any danger. All youths were accounted for, and the complainant was turned over to a guardian.

01/07/2023 10:19am A resident of Manville Road reported that her driveway was blocked by a parked car and she was unable to get out. The responding officer was able to locate the owner of the vehicle and have the vehicle moved.

01/07/2023 7:26pm A resident of Mount Pleasant reported locating a loose dog in her neighborhood. When the owner called to report the dog missing approximately an hour later, the Desk Officer contacted the original caller, and the dog was returned.

01/07/2023 10:01pm A local resident reported an odor of gas on Bedford Road near the intersection with Pleasantville Road. The responding officers confirmed the odor, and remained on scene until Pleasantville FD and Con-Edison responded to take control of the scene.

01/07/2023 11:03pm The sister of the woman involved reported a domestic incident at a home in the Village. Responding officers located the suspect at the home with multiple friends. Both parties involved reported that the altercation was verbal in nature only. Following the investigation on scene, it was determined that no offenses were committed and the parties were separated for the night. A NYS Domestic Incident report was filed, and both parties were advised of civil remedies and services to address the existing issues in the home.

01/08/2023 7:57am A resident of Washington Avenue reported sewage backing up into his basement. DPW was notified, and responded to correct the condition.

01/08/2023 8:18am A resident on Mountain Road called to report that a pipe in her front yard had burst, and was now spilling down the road. DPW was notified of the incident, and responded to correct the condition.

01/08/2023 6:18pm An anonymous family member reported a woman who resides in the Village has become suicidal and has been making threats of self-harm. The woman denied the report to the responding officers, but when presented with the text messages she had sent to her family member, the woman was transported by Pleasantville VAC to the hospital for a mental health evaluation.
