

## **BLOTTER SUMMARY**

**January 9 through January 15, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

01/09/2023 12:10pm A resident of Yorktown Heights reported a dog running in the road without a leash/collar in the area of Manville Road and Brookfield Place. Upon arriving in the area, the responding officer located the dog on its property nearby.

01/09/2023 3:25pm A resident of Treetop Lane reported her elderly mother was unresponsive. The ambulance and the paramedic were dispatched. Responding officers were able to revive the woman, whose condition improved to the point that she refused further medical attention.

01/09/2023 3:44pm A vehicle with no registration and multiple equipment violations was reported parked on Romer Avenue. Upon further investigation, responding officers learned that the vehicle belonged to the deceased father of a nearby resident. In addition, the battery had died, so the vehicle was unable to be moved off the road. Officers provided the family time to address the issues and move the vehicle.

01/09/2023 11:47pm A local resident called 911 to report that his friend had fallen and was bleeding heavily. Although they did not know their exact location, the caller stated they were near a gas station. The responding officers located the injured party on Hobby Street near Marble Avenue, and learned that the man had consumed many beers and then fell off a three-foot wall, causing lacerations to his face. The officers provided medical assistance until EMS arrived, and the injured party was transported to the hospital by Pleasantville VAC.

01/09/2023 11:13am A local business owner reported opened FedEx boxes scattered about on the ground on Irvington Street. An investigation is ongoing.

01/10/2023 11:50am A resident of Eastchester came into police HQ to report the larceny of a check that he had deposited in the USPS drop box on Bedford Road. After it had been stolen, the check was rewritten to a different person for a different amount, but the bank

had detected the fraud and did not remove any funds from the victim's account. A report was filed regarding the incident, and an investigation is pending into the matter.

01/10/2023 6:23pm The central monitoring station for an alarm company reported an automatic burglar alarm at a business on Bedford Road. The responding officers discovered that the alarm was set off in error by an employee.

01/10/2023 9:52pm County Fire Control requested an ambulance and police response to a residence on Bedford Road for an elderly woman with injuries from a fall. The responding officers assisted EMS in removing the patient from the residence, and she was subsequently transported by Pleasantville VAC to a local hospital.

01/11/2023 8:33am Con Edison requested assistance in locating the owners of several vehicles parked on Guion Street that were blocking an area slated for excavation and improvement. The responding officer was able to locate all owners, and the vehicles were moved without incident.

The defendant was transported to police HQ for processing and released with an appearance ticket.

A NY State Accident Report was filed, and one vehicle had to be towed from the scene.
