

## **BLOTTER SUMMARY**

**4/11/2022 through 4/17/2022**

The Blotter reports below represent a selection of reports made between the dates above.

04/11/2022 5:58am County Fire Control reported a gas leak at a business on Wheeler Avenue. Officers on scene assisted in traffic control and scene security while Fire Department and Con Edison personnel determined the location of the leak.

04/11/2022 9:36am This department was advised by County Fire Control that an elderly party had fallen at her residence on William Street. Responding officers assisted the woman and made her comfortable while awaiting the ambulance and paramedic to arrive. The woman declined further medical attention and decided not to go to the hospital.

04/11/2022 1:38pm A resident of Garrigan Avenue reported a young person operating a scooter in Memorial Plaza unsafely. The operator had left the area prior to the officer's arrival.

04/11/2022 2:40pm A resident of Pleasantville reported that his father was going in and out of consciousness and having difficulty breathing. When responding officers arrived, the man refused further medical attention.

04/11/2022 6:35pm A resident of Thomas Street called to report a dispute in the roadway in front of his residence. Upon arrival, officers discovered a domestic dispute between a recently-engaged couple in the street. Both parties were separated without incident, and the officers determined the dispute was verbal only between the two parties involved. Both left separately and agreed to cool down and discuss issues in their relationship at a later time. A NYS Domestic Incident Report was filed.

04/12/2022 12:02am The central station monitoring service for an alarm company advised of a bedroom window activation at a residence on Weskora Avenue. Responding officers determined the alarm was set off erroneously by the homeowner.

04/12/2022 8:58am An anonymous driver reported a large boulder in the middle of the roadway on Bedford Road near the intersection with Pierce Drive. Officers checked the length of Bedford Road between Manville Road to the Village line and did not observe any road hazards.

04/12/2022 7:24pm A Bedford Road resident reported a possible burglary from his apartment. Upon arrival, officers interviewed both the caller and his roommate and determined there was a misunderstanding on the location of property within the apartment. The items that were first reported missing had been relocated to another room.

4/12/2022 8:55pm A resident of the Clinton Street Center called to report that she had fallen and requested assistance. Responding officers were able to render assistance and the caller was comfortable upon the officer's departure.

4/12/2022 9:20pm The manager of a local nightlife establishment reported an unwanted patron in his business. The manager reported that the person, who had previously been asked to leave and told he was unwelcome, had returned. The manager did not wish to press charges against the customer, who is known to this Department, so the incident was documented with a report.

04/13/2022 9:27am A customer of a coffee shop on Washington Avenue reported a fellow customer was unconscious. Officers were dispatched to the scene along with Pleasantville VAC and the paramedic. Once the woman regained consciousness and was examined by medical personnel on scene, she refused hospital transport.

4/13/2022 9:48am The Parks and Recreation Department foreman reported a damaged exterior camera at the Pleasantville Pool on Lake Street. The camera appeared to have been intentionally struck with a blunt object. The investigation is continuing.

4/13/2022 4:52pm A resident of Bedford Road reported a man going through the garbage in front of her neighbor's house. Officers located the man, who stated he is homeless, but staying in shelters in White Plains, and was in the area searching for recyclables to return. The man was coherent and did not appear to be a danger to himself or others. He was offered assistance and social services, which he declined.

04/13/2022 5:12pm A resident of Mountain Road called to request EMS due to pain he was having in his hip. He further reported that he had fallen earlier in the day, and was now experiencing substantial pain. Officers attempted to keep the patient comfortable awaiting the arrival of the ambulance. The patient was transported to the hospital via Westchester EMS.

04/13/2022 8:48pm A Village employee reported she had been at the Pleasantville Pool and observed a man in a blue car who may be in need of medical assistance. Officers located the car and the man, who was sleeping in his vehicle. Although he was not sick or injured, the officers assisted him to call his father who came and drove him to his home on Marble Avenue.

04/14/2022 12:10am A resident of Pleasantville who is currently away on vacation called to request a check of his property. The property was checked and everything was found to be in order. The caller was also advised of the Vacant House Watch Request (Dark House) Form available on the Village website. (Home ›› Departments ›› Police Department ›› Forms & Documents).

04/14/2022 5:06am The central station monitoring system for an alarm company reported a commercial interior alarm activation at a business on Marble Avenue. Responding officers checked the building and found the property secure and nothing unusual on the ground floor.

04/14/2022 1:43pm A resident of Foxwood Condominiums came to Police HQ to report being the victim of fraud. Having noticed unusual activity on her account, she spoke to a party she believed was from Citibank. During the conversation, she provided personal financial information in order to attempt to remedy the situation. The investigation is ongoing.

04/14/2022 9:19pm Multiple callers reported a group of youths in the roadway and yelling at passing cars in the area of Broadway and Seneca Lane. Officers located the youths and assisted the residential facility staff to safely return the students involved to campus.

04/15/2022 2:30am Mount Pleasant Police requested assistance searching for two AWOL students from a residential treatment facility on Broadway. Officers located the two

youths on the Metro North train platform and notified facility staff, who transported them back to campus without incident.

04/15/2022 11:44am Following an altercation at the Thornwood Town Center, Mount Pleasant Police requested assistance searching the area for a vehicle that left the scene and headed north on Broadway. Officers checked the area but did not locate the vehicle.

04/15/2022 12:50pm Following a minor property damage accident in the parking lot of a restaurant on Marble Avenue, officers facilitated the exchange of information between the two vehicle owners.

04/15/2022 4:38pm While on patrol, Sgt. Woods came upon a property damage accident between a car and a Bee-Line bus on Bedford Road. Officers determined that the bus was parked and the other vehicle collided with it while attempting to pass. No injuries were reported, and while the bus was able to continue on its route, but the car needed to be towed to a private tow yard. A NY State Accident Report was generated.

04/15/2022 6:31pm The central station monitoring service for an alarm company reported a commercial burglar alarm activation at a business on Bedford Road. Responding officers found an open front door and made entry to the location. After searching the building, the officers found no sign of forced entry or criminality. A keyholder was contacted to respond to re-secure the door.

04/15/2022 10:36pm Officers checked the area of Cooley Street for parking violations. While no violations were observed and no summonses were issued, officers used the opportunity to interact with patrons and business owners in the area to inform them of applicable parking regulations and alternatives to illegal parking.

04/16/2022 1:00am A resident of Sarles Lane reports that an assemblage of youths are causing a commotion; hooting and hollering in the wooded area at the dead end of Pleasant Avenue. Responding officers searched the known hangout area, along with an expanded area beyond what was described, with negative results.

04/16/2022 5:00am Despite posted signs and messaging via various media sources, one (1) car was impounded and towed from Memorial Plaza for being in violation of the Farmer's Market parking restrictions.

04/16/2022 11:38am A resident of New Jersey who was visiting a residence on Marble Avenue reported that her two-year-old daughter had swallowed a penny. Officers responded and found that the child did not seem to be suffering any ill effects. The responding paramedic examined the child and determined that she had completely swallowed the penny, and it did not present a threat to her breathing. The mother refused further medical attention and committed to seeing the child's primary care physician for a follow-up.

04/16/2022 4:51pm County Fire Control reported a fire alarm activation at a restaurant on Bedford Road. Responding officers assisted Pleasantville FD with traffic control and scene security. The alarm was determined to have been activated in response to a party vaping in a bathroom.

04/16/2022 6:22pm The manager of an auto repair shop on Marble Avenue reported that a previous customer had been at the location just after closing and made threats to the employees. The woman was reported to have threatened to sic her dog on employees and cause damage with a firearm. No firearm was displayed. The woman had left the scene prior to the call being made to the police Department, but the manager knew the customer from her previous business. The manager did not wish to pursue criminal charges against the woman. Officers responded to her home and interviewed her, where they learned she was upset about a previous service the business had performed. It was further determined she did not own a firearm. Officers advised her on how to file a civil complaint and how to properly act in public.

04/16/2022 8:24pm A Pleasantville resident notified this Department of a disturbance that had occurred on Marble Avenue, and that some of the parties involved were leaving the scene, headed north. Although it was determined that the incident itself occurred in the jurisdiction of the Mount Pleasant Police Department, Pleasantville officers were able to assist in locating the parties involved and discuss possible outcomes.

4/16/2022 11:17pm An anonymous caller reported parking violations on Cooley Street. The vehicles were moved prior to the arrival of officers.

04/17/2022 8:38am A personal alarm monitoring service called to report a Medic-Alert alarm activation at an apartment at the Clinton Street Center. Responding officers needed to forcefully defeat the chain lock to enter the apartment, where they found the resident on the floor after a fall. The resident reported she had fallen in another room and had to make her way to the living room to activate her alarm. Officers remained with the woman pending the ambulance and paramedic, and she was taken to the hospital via Pleasantville VAC.

04/17/2022 11:44am A resident of Lake Street reported a suspicious vehicle parked on the aqueduct. Officers were able to locate the vehicle's owner, who is a resident of Bear Ridge Road and was out walking her dog. She was advised that she was parked on private property and not allowed to be there. She and the dog left in her vehicle without further incident.

04/17/2022 12:41pm Officers responded to William Street to address an ongoing neighbor dispute. Two neighbors had been in conflict regarding parking and littering. Officers were able to mitigate the current situation and, hopefully, address the ongoing issues, but no further police action was taken.

04/17/2022 2:59pm A resident of Edgewood Avenue called 911 to report she was having difficulty breathing. Responding officers found her on her knees on her front porch. They administered oxygen while awaiting the arrival of EMS. She was transported to the hospital via Pleasantville VAC.

04/17/2022 10:12pm This Department received multiple 911 calls regarding a motor vehicle accident with injuries and an unresponsive driver on Broadway. The driver had failed to navigate the turn from an access road onto Broadway and crashed into a stone wall on the opposite side of the street. Upon the officer's arrival, the driver was out of the vehicle lying on the ground, and had regained consciousness. The investigation determined that the vehicle had been recently stolen from Thornwood. The driver was transported to the hospital by Pleasantville VAC, and charged with felony Criminal Possession of Stolen Property.
