The Blotter reports below represent a selection of reports made between the dates above.

05/01/2023 2:57am County Fire Control reported a resident on Meadow Lane feeling faint and dizzy. An ambulance and paramedic were dispatched, and responding officers found the aided person conscious and alert. The patient was transported to the hospital by Pleasantville VAC.

05/01/2023 5:31am A resident of Guion Street reported her adult son was having a seizure and needed EMS. The ambulance and the paramedic were dispatched, and responding officers provided basic medical care until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.
