## **BLOTTER SUMMARY**

## May 8 through May 14, 2023

The Blotter reports below represent a selection of reports made between the dates above.

05/08/2023 4:11am New Castle PD reported that they had been notified that a resident on Washington Avenue was concerned there was someone in her house. Responding officers determined that the call was made in error by a person outside Pleasantville jurisdiction.

05/08/2023 9:34am A caregiver reported the young woman she was assisting was having a seizure on the MTA train platform. The medic and the ambulance were dispatched.
