

BLOTTER SUMMARY

4/25/2022 through 5/1/2022

The Blotter reports below represent a selection of reports made between the dates above.

4/25/2022 10:59am An employee at a preschool on Bedford Road reported suspicious trash in the playground that appears to have been left by youths congregating during the overnight hours. The responding officer recovered an empty drink can, chip bag, and lighter, among other various items. A report was filed, and an email was sent to all officers in Patrol advising units to check the area during overnight hours.

04/25/2022 8:11pm County Fire Control advised the police Desk of a Fire Department dispatch to a home on Academy Street for a fire in an outdoor grill. The responding officer was able to assist the homeowner douse the flames with a fire extinguisher.

04/26/2022 8:49am A resident of Saratoga Avenue reported a noise complaint regarding her neighbor's dog barking. The responding officer found the area quiet upon his arrival, but spoke to the dog's owner regarding the village code prohibiting unreasonable noise.

04/26/2022 11:55am A woman requested medical attention for her mother, who lives in Foxwood Condominiums. The mother has been bedridden for the past few months, and currently had not been eating or drinking and was disoriented. Upon the arrival of the ambulance, officers assisted in transferring her to the stretcher. She was transported to the hospital via Pleasantville VAC.

04/26/2022 4:11pm A concerned acquaintance called in regards to her friend, a resident of Wheeler Avenue from whom she has not heard in some time. Officers were dispatched to the home for a welfare check, and upon contact with the above individual it was determined that further medical care was needed. Said individual was transported to a local hospital via Pleasantville VAC and her acquaintance was updated as to her status.

04/26/2022 4:19pm This Department was notified by the Mount Pleasant Police Department of youths riding all-terrain vehicles (ATV's) on the Catskill Aqueduct near Lake Street. Responding officers found the area quiet upon their arrival.

04/27/2022 1:22pm A resident of Chappaqua reported she had locked her keys inside of her vehicle in the area of Washington Avenue. PO Bangurra was able to retrieve the keys and assist the car owner.

04/27/2022 2:02pm A Great Oak Lane resident reports that she left her teal Trek ladies' bicycle in front of the Mount Pleasant Library on April 25th at around 2:45, and when she returned the following morning it was missing. The incident is currently under investigation.

Responding officers mediated the situation, and advised all parties involved that such matters were could be worked out amicably.

They further reported CPS found no basis for the complaint. Although the reporting person was kept confidential, the family suspected they knew who made the complaint, and it was intentionally false. The investigation is continuing.

04/28/2022 8:59am A resident of Pleasantville Road called to request a welfare check on her aunt in Foxwood Condominiums. She reported she talks to her aunt every morning, but she is currently not answering her phone. Responding officers found the aunt safe and secure, who reported she did not answer the phone because she is sick of spam calls.

04/28/2022 10:10am A neighbor reported a woman in a medical emergency in a residence on Wheeler Avenue. Responding officers administered oxygen and kept her comfortable pending the arrival of the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

04/28/2022 12:17pm A resident of Sunnyside Avenue states that her significant other has fallen and cannot get up at this time. The officer who responded provided comfort for the injured party until Pleasantville VAC and a paramedic arrived. With the help of responding officers, the injured party was loaded into the ambulance and was transported to a local hospital.

04/28/2022 6:05pm Caller from Saratoga Avenue reports an unidentified male fixing his car on the street and leaving oil stains on the roadway, potentially causing a hazardous condition. Patrol responded and located the male and advised him to cease activity, and in the future to repair his vehicle in his driveway.

04/29/2022 7:31pm This department was contacted by Toyota Emergency Service which stated that a driver in a Toyota Prius had pressed the emergency button in the area of Broadway and Church Street. Officers checked the surrounding area and were unable to find the vehicle in question. The emergency service was contacted and advised of the findings.

04/30/2022 1:25AM Received call from party stating that he and a friend were forcibly removed from a bar on Bedford Road for "no reason". When asked for the reason he was given, he said that he was told he was drunk, but he said he was sober. The caller stated that he was currently at a gas station next to the establishment. Officers reported a search of the area with negative results.

04/30/2022 8:06am A resident of Edgewood Avenue called the Police Department to report that his neighbor's landscapers were operating a lawnmower outside of the hours permitted on weekends. The responding officer spoke to the landscaper and informed him of the village code relating to noise on weekends and advised him to wait until 9:00am.

04/30/2022 8:07pm A resident of Pleasantville requesting police and EMS for a young man who is unresponsive. Patrol officers arrived on the scene to find a male lying on the couch unresponsive with light pulse and shallow breathing. Witnesses reported that the man had taken some medication he had been prescribed, but took an unknown amount. Officers administered 2 doses of nasal Narcan, after which the male patient quickly became alert and oriented. Oxygen was administered until EMS arrival. The patient was transported to the hospital via Pleasantville VAC.

05/01/2022 2:13am A resident of Hobby Street reported approximately six (6) unknown males fighting in the street. When interviewed the group stated that they were not fighting, and that they were just talking in the street. Officers witnessed no evidence of a physical disturbance. All parties were dispersed without incident.

05/01/22 10:16am A resident of Great Oak Lane reports that his elderly mother has fallen and sustained injuries to her head and her leg. Responding officers administered first aid until EMS and the paramedic arrived. The patient was transported to the hospital via Pleasantville VAC.

05/01/2022 5:03pm A resident of Weskora Avenue reported that approximately 10 minutes in the past, a late model, blue Subaru wagon with multiple bumper stickers and occupied by at least six young people, was driving at a high rate of speed in the area of Roselle Park. The caller stated she attempted to have the youths slow down, but they continued at a high rate of speed and left the immediate area. Patrol units canvassed the area with negative results.

05/01/2022 10:43pm A resident of Pleasant Manor Apartments requested police and an ambulance for her 91-year-old mother who is unable to walk. Despite a language barrier and with an officer serving as a translator, officers determined that woman was losing motor coordination in her extremities. Officers remained with the woman awaiting the arrival of the ambulance and the paramedic, and she was transported via Pleasantville VAC to the hospital.
