The Blotter reports below represent a selection of reports made between the dates above.

06/05/2023 5:46am Multiple callers reported two large dogs in the roadway near the intersection of Bedford Road and Choate Lane. The responding officers reported that the dogs were located by Mount Pleasant Police and returned to their owner.
