

## **BLOTTER SUMMARY**

**5/2/2022 through 5/8/2022**

The Blotter reports below represent a selection of reports made between the dates above.

05/02/2022 5:39pm 911 call received in which caller states he believes he is having a heart attack at a restaurant on Wheeler Avenue. Officers arrived on scene and advised that the male party conscious and alert. Male was seated and oxygen was administered by officers until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

05/02/2022 2:30am Received a 911 call from a village resident on Meadow Lane regarding an ex-girlfriend who is attempting to gain entry to his residence. Responding officers report placing a 24-year-old female under arrest. The Defendant was transported to police HQ, and processed for the charge of Assault in the Second Degree.

05/03/2022 12:44am A Grove Street resident reports hearing loud voices behind her residence. Responding officers canvassed the surrounding area with negative results.

05/03/2022 11:43am A village employee called in what was loud yelling/possible disturbance coming from the MTA platform on the Bedford Road side. Upon arrival Officers were met by a Cottage School staff member who was trying to get 2 AWOL youths back to campus. Said youths got into a verbal altercation and fled the scene. Being that the youths were not a harm to themselves or others, staff was advised that patrol officers would keep an eye out for them and would advise staff if they were located.

05/03/2022 5:00pm Male resident in HQ producing full stay Order of Protection issued by Westchester County Family court for him and his two children against his wife. Male provided copy to be served by this department. Shortly later, female respondent was served said Order of Protection at Police HQ by patrol officers. Minutes after leaving HQ female entered the residence she was ordered to stay away from, removed items and left. Said residence was occupied by all three protected parties. Patrol officers had female respond back to Police HQ where she was subsequently arrested and charged with Criminal Contempt for violating said Order of Protection. Female processed without incident and released ROR post arraignment in Pleasantville Village Court.

05/04/2022 4:45am Caller requests police assistance at her residence on Washington Avenue stating that she had slid off of her bed, and could not get up off the floor. Responding officers were able to gain entry into the apartment and assist the fallen party off the floor.

05/04/2022 1:18pm A female caller reports that a box truck is stuck on the bottom of the hill at Bedford Road and Academy Street. Officers requested a heavy tow truck from a local tow company. Vehicle was removed successfully.

5/04/2022 8:27pm Received call from a party stating that her husband was on the ground and unresponsive in their yard. Caller was unsure if her husband was breathing. Officers and EMS arrived on scene, and it was determined that the aided party was deceased. The Medical Examiner's office was contacted, and the deceased was released to a private funeral home. Officers remained on scene with caller until the deceased was removed from the residence.

05/04/2022 9:19am The store manager from a coffee shop in Memorial Plaza called to report a disorderly customer at the establishment. The female customer reportedly was creating a disturbance by talking to people and voicing her opinions, which caused the other customers to feel uncomfortable and leave. Officers were able to locate the female who was identified and who agreed to leave the establishment.

05/05/2022 4:32pm Party in HQ reporting a possible theft from a vehicle. Complainant stated that he believes that his backpack was taken from his vehicle while it was parked on Bedford Road across from the Taco Project. Investigation is ongoing.

05/06/2022 11:58am Pleasantville High School staff advises that their students are planning a walkout protest in regards to the reported pending reversal of Roe v Wade, and requested law enforcement presence to facilitate the peaceful expression of their ideas. Officers on scene reported that no issue arose from either the protesters or possible counter-protesters, and students dispersed peacefully after the event was over.

05/06/2022 4:31pm Officer reported being flagged down outside of the Clinton Street Center by a woman stating that that she is a visiting nurse, and she has been unable to make

contact with one of her patients, who lives at the Center. Officers responded to the patient's apartment, and found her well. No further actions taken.

05/07/2022 2:21pm ADT called to report an alarm activation to a residence on Washington Avenue. Officers checked the perimeter of the residence and reported all secure.

05/07/2022 4:47pm Received a 911 hang up from residence on Brookfield Place. An attempt to call the number resulted in no answer. Patrol arrived on scene and reported that no one was home and the residence appeared secure.

05/08/2022 12:30am Received a call from employee at a gas station on Marble Avenue reporting a party passed out in the parking lot. Officers arrived on scene, and found party awake, but intoxicated. Officers determined that the party did not require medical attention, and provided him a courtesy ride to his residence.

5/8/2022 2:32pm A Skytop Drive resident reports an oil smell coming from a drain on her property. Pleasantville Fire dispatched and it was determined that the oil smell was a result of an issue with the sump pump.

05/08/2022 7:00pm A King Street resident reports multiple vehicles obstructing access to his driveway. Responding officer reports that vehicles are parked legally and are not causing an obstruction. No further action taken.
