BLOTTER SUMMARY

5/9/2022 through 5/15/2022

The Blotter reports below represent a selection of reports made between the dates above.

05/09/2022 9:03am Pace University Security requested assistance for a student who believed she may have been robbed of her cell phone in Memorial Plaza. Due to the lack of clarity on where the incident may have occurred, Metro North Police were contacted for assistance. An investigation of the incident discovered that the phone had been misplaced, not stolen, and was eventually recovered in Memorial Plaza.

05/09/2022 10:56am The owner of a business on Marble Avenue reported a car parked in his lot was parked by someone who worked in the area and was not patronizing his business. When he approached the woman, she failed to relocate her car. Officers spoke to the woman and she agreed to find another parking space.

05/09/2022 12:31pm A person called requesting EMS for an elderly neighbor who had fallen out of bed and was having an unknown type of medical issue. Upon their arrival, officers found the aided party lying on the ground next to his bed. Since he was not in pain, officers remained with him until EMS arrived. They assisted the mutual aid ambulance in preparing him for transport to the hospital.

05/09/2022 9:54pm Sgt. Zane reported being on a traffic stop on Bedford Road with a driver who committed a traffic violation. Based upon the totality of his observations, the driver, a resident of New Hampshire, was placed under arrest for Driving While Intoxicated. The vehicle was impounded, and the driver was transported to police HQ for processing, after which she was released without bail.

05/10/2022 12:57am A central station monitoring system called to report a commercial alarm activation at a business on Broadway. Officers checked the location and reported that the ground floor of the business was secure.

05/10/2022 10:46am A father in Florida called to report concerns about his daughter, who is currently living in Pleasantville with an unknown male. The father stated that after she was expelled from a local college, she has failed to find a steady living arrangement. The father was concerned for her physical and mental health. Officers were dispatched to her residence, but she was not there. They contacted her landlord before finally speaking to her directly later in the evening. Officers did not observe her to be in crisis or a threat to herself, but a social services team was notified, who stated they

would be following up with her. The father was notified of the current situation, and was told that Officers would continue to follow up as well.

05/10/2022 5:48pm A resident of the Village called to request assistance helping his elderly father up from the floor. Officers were able to provide assistance, but a short time later, the man called again reporting that his father had fallen. Officers kept him comfortable while awaiting the ambulance and paramedic. The patient was transported to the hospital via Pleasantville VAC.

05/10/2022 8:06pm A resident of Pleasantville called to report a violation of an Order of Protection. The respondent had sent him harassing text messages, which is a violation of the terms of the valid Order of Protection. The violator could not be located, so evidence was gathered and a case report was generated.

05/11/2022 1:17am While investigating a possible suspicious vehicle in the area of Cooley Street, officers heard a motor vehicle accident. They soon discovered that a vehicle had struck two parked cars while trying to navigate the turn from Cooley Street to Bedford Road. Based upon the totality of his observations, PO Paredes determined that the driver, a resident of Bronxville, was intoxicated and placed him under arrest for Driving While Intoxicated. During the processing of the arrest, officers discovered a non-conforming rifle and high-capacity magazines in the vehicle. The driver was charged with multiple felony weapons counts, and following the administration of a breath test, Aggravated Driving While Intoxicated.

05/11/2022 4:06am When the respondent in the T.O.P. violation case from 8:06pm came to Police HQ seeking to return to the residence, she was placed under arrest for violating the Order. She was processed and held pending arraignment, at which she was released without bail by the Village Justice.

05/11/2022 2:43pm A Bedford Road resident reported that on successive days, a suspicious party had come to her residence, knocked on the front door, and then sat in a vehicle in the driveway for several minutes. The caller stated that the party had already left the area prior to them calling the police. The caller provided a license plate number to Officers, but it did not match the vehicle description. Officers used police cameras situated on roadways throughout the village to locate the vehicle, and the correct plate number. Further investigation revealed that the party in question worked for a tile company, and that he was attempting to pick up tile samples that had previously been dropped off at the residence.

05/11/2022 11:47pm Officers responded to a business on Marble Avenue to meet a person who admitted to committing a Criminal Mischief three days prior to a vehicle in Southeast Pleasantville, and who wanted to surrender himself. The man confessed to damaging the rear window of another vehicle with a tire iron, resulting in property repairs in excess of \$300. Upon further investigation, the man's story was corroborated and he was placed under arrest. He was transported to Police HQ, where he was processed and held to be arraigned before the Village Justice Court on a charge of Criminal Mischief in the Third Degree, an E Felony.

05/12/2022 1:07am A concerned passer-by reported a man passed out in the breezeway over the Metro North train tracks. Responding officers located the man, who is known to this Department, and offered social services, which he refused.

05/12/2022 9:23am The manager of a vehicle repair facility on Marble Avenue reported that two of the store windows had been damaged, and appear to have been shot with a firearm. Patrol Officers and a Detective were dispatched to collect evidence and process the crime scene. The matter is currently under investigation.
