## **BLOTTER SUMMARY**

## 5/16/2022 through 5/22/2022

The Blotter reports below represent a selection of reports made between the dates above.

05/16/2022 12:10pm A resident of Wappingers Falls called to report that her ride from the airport did not arrive, and she was concerned for his well-being. Officers assisted the woman in accessing her personal belongings that were in his car, which was still parked at his place of employment, although his boss stated he had not seen him for some time. The responding officer also contacted the Westchester County Department of Public Safety for a welfare check, as the man was a resident of Mount Kisco, who determined he was fine.
