## **BLOTTER SUMMARY**

## 4/18/2022 through 4/24/2022

The Blotter reports below represent a selection of reports made between the dates above.

04/18/2022 8:17am The central monitoring station for an alarm company called to report an alarm activation at a business on Tompkins Avenue. Upon arrival, the responding officer was met by contractors who accidentally set it off while doing work at the location. The officers collected pedigree information and documented the incident with a report.

04/18/2022 12:37pm A resident of the village came to HQ to report that he was the victim of identity theft. After receiving a debit card from "Bluebird" in his name for which he did not apply, he also realized an unknown party had opened a credit card in his name through "Metabank." The victim had no business dealings with, or knowledge of, either of those companies prior to receiving the debit card. The victim was advised to contact the companies and cancel the accounts, and was provided information on credit monitoring. A Case report was forwarded to the Detective Division.

04/18/2022 4:45pm A resident of Fairway Drive reported an occupied dark-colored sedan with tinted windows sitting in the cul-de-sac for approximately 30 minutes. Responding officers identified the driver, who was a real estate agent waiting for a client to arrive.

04/18/2022 5:19pm A resident of California who was walking through the MTA Breezeway located a lost wallet and turned it in to Police HQ. The Desk Officer was able to find contact information for the owner, a resident of Croton, and arrange for the wallet to be returned to her.

04/19/2022 2:19am A resident of Greenmeadow Road reported a power outage at his home. Responding offices discovered that a tree had fallen, taking down power lines. The area was secured, and Con Edison was contacted for emergency response.

04/19/2022 4:42am Westchester County Police advised the Police Desk that they had been contacted by Mercedes-Benz Emergency Monitoring of a crash in Memorial Plaza.

Responding officers found a 2020 Mercedes-Benz, damaged and parked in the train station lot with its hazard lights on, as well as damage to multiple signs and parking meters. After being medically cleared, the driver of the vehicle was arrested and charged with Grand Larceny 2<sup>nd</sup> Degree, and Possession of Stolen Property 2<sup>nd</sup> Degree, both C Felonies, as well as other charges. After the arrest was made, a resident of Vanderbilt Avenue reported the same man had attempted to steal his car prior to taking the Mercedes. He was arraigned and released on his own recognizance. A NYS Auto Accident was filed.

04/19/2022 8:03am County Fire Control reported an elderly party passed out at a home on Greenmeadow Road. Upon the officer's arrival, the man had regained consciousness, so they kept him comfortable while awaiting the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

04/19/2022 2:50pm A taxi driver reported that a fare he had transported to Pleasantville from Newark Airport the previous night had left her purse in his taxi. The Desk Officer was able to make contact with the owner of the purse and facilitate the exchange of contact information so she could retrieve her purse.

Responding officers located the dog, a white female pit bull, and contacted the owner via the information on her collar. The owner, a resident of Washington Avenue, responded to the scene to retrieve the dog.

Responding officers found her disoriented and confused, so they contacted her son and daughter who responded to the home. 04/19/2022 8:58pm The owner of a business on Marble Avenue contacted Pleasantville HQ after he received an alert from his alarm company which appeared to show somebody attempting to burglarize his store. Patrol was dispatched and advised that nobody was in the store, but an unlocked window was located. The business owner responded to the

location and interior search was conducted with negative findings. The window was secured upon the officer's departure.

The party, described as a heavyset male in a hooded sweatshirt, opened her screen door, and then proceeded to walk around on the porch. He fled the scene when she activated her security alarm. Responding officers found the resident had fallen and suffered an injury to her arm, so they provided first aid to the woman awaiting the arrival of EMS. She was transported to the hospital via Pleasantville VAC.

04/20/2022 3:18am A resident of Wilton Street called 911 to report that someone had attempted to steal his car from his driveway. He reported his wife had heard car doors slamming, and when she looked outside, she saw someone attempting to enter the family car. When she yelled out to him, he fled into a waiting SUV occupied by multiple other people. She was unable to give a description of any of the people involved, but video evidence was located, and with the assistance of Mount Pleasant Police Department and the Westchester County Police, license plate information for two SUV's (both stolen) was gathered. 04/20/2022 6:42pm A resident of Hopper Street reported parking violations near his home. The responding officer issued multiple parking summonses to vehicles in violation.

Responding officers assisted getting the man upright and returning him home, where he refused further medical attention from the paramedic and the ambulance.

A case report was prepared and an investigation commenced, including a recording of the suspect description, the completion of an owner's deposition, and the collection of video evidence. All the information was forwarded to the Detective Division for a follow-up.

04/21/2022 9:58pm An employee of a business on Wheeler Avenue called to report a smke condition inside the laundromat. Responding officers confirmed the report and ensured there was no one inside. Pleasantville FD was dispatched and determined that a small fire had begun in one of the dryers, but it had extinguished itself. The fire was not deemed suspicious.

0422/22 8:58am A resident of the Sherman Park area of Pleasantville requested a lift assist for her elderly mother. Officers confirmed the woman was uninjured and completed the lift assist without incident.

While performing a check of the exterior of the residence, the homeowner arrived. The officer accompanied her to check the interior of the residence as well, but found nothing out of place.

Following his transport to Pleasantville PD HQ for processing, his level of intoxication was such that the determination was made to get him medical attention. The man was given an Appearance Ticket to appear in court at a later date and transported to the hospital via Pleasantville VAC.

04/24/2022 8:37pm A resident of Guion Street reported an illegally parked car near his home. Responding officers located the owner, who was from out of town visiting family, and the vehicle was moved into the driveway.
