

## **BLOTTER SUMMARY**

**11/29/2021 – 12/05/2021**

The blotter reports listed below represent a selection of reports made between the dates listed above.

11/29/2021 9:56am A female driver called to report a road rage incident with another driver, who yelled at her and followed her into a gas station on Marble Avenue. The angry driver left the scene prior to the officers' arrival, and the caller could not provide a description of the car or the driver.

11/29/2021 2:29pm The crossing guard at Manville Road and Academy Street called to report a truck stuck on the hill of Academy Street. Officers arrived for traffic control and a tow truck was called to clear the truck from the hill.

11/29/2021 6:20pm A resident of Ashland Avenue reports he hears a man on the track at the Middle School cursing and yelling. No description was provided because it was dark. The man was gone upon the officer's arrival.

The man was transported to the hospital.
