The Blotter reports below represent a selection of reports made between the dates above.

08/01/2022 6:51am Public Works staff members advised PO Casale that a person was sleeping in front of the Recreation Department on Marble Avenue. PO Casale located the man, who is known to this Department and is currently unhoused. He offered social services and assistance to the man, but was refused. The man was sent on his way.

08/01/2022 11:33am An anonymous caller reported that a pregnant customer had fainted at a commercial establishment on Marble Avenue. The woman was awake and alert upon the arrival of responding officers, and refused further medical attention.
