**Village Election Calendar – Tuesday, March 21, 2023**  
**Villages of Bronxville, Elmsford, Pleasantville, Port Chester,**  
**Rye Brook, and Sleepy Hollow**

- 12/6/22 FIRST day to sign a party designating petition.
- 12/30/22 FIRST filing of Financial Disclosure for village primary Section 6200.1 and 6200.2, Rules and Reg. of New York State Board of Elections.
- 1/3/23 FIRST day to file a petition to cause a permissive referendum to appear on the General Election ballot.
- 1/3/23 FIRST day to sign an independent nominating petition.
- 1/9-1/17/23 DATES to file party designating petition for village primary, Sec. 6-210.2.d.
- 1/10-1/17/23 DATES to post and file notice of party caucus either by newspaper publication once within the village at least one week and not more than two weeks preceding the caucus.
- 1/10-1/18/23 DATES to file written general objections to designating petition, or day after petition is received by the board of elections if such petition is mailed within the time permitted by law, whichever is later. Written specifications of objections must be filed within two days thereafter, Sec. 6-212.
- 1/12-1/20/23 DATES to file certificate of declination or acceptance of party designation: MUST BE WITHIN 3 DAYS OF FILING OF DESIGNATING PETITION, Sec. 6-210.2.e. BOE shall within one day notify the committee to fill vacancies. Certificate to fill vacancy caused by declination or any other reason must be filed within 3 days after the date of the notice to the committee and shall have designated person(s) written consent.
- 1/13-1/23/23 DATES to file written general objections to certificate of declination or acceptance, or day after certificate is received by the board of elections if such certificate is mailed within the time permitted by law, whichever is later. Written specifications of objections must be filed within two days thereafter, Sec. 6-212.
- 1/17-1/23/23 DATES to post and file notice of party caucus (at least 10 days before caucus) in office of village clerk and county board of elections depending on date of caucus or by posting

such notice in six public places in the village at least 10 days preceding the day of the caucus, Sec. 6-202.3.

\*BOE to furnish enrollment list to village chair of caucus. Sec. 6-202 (4).

- 1/17-1/24/23 LAST day to publish notice of party caucus in newspaper, depending on date of caucus. Not later than one week before caucus.
- 1/20/23 SECOND filing Financial Disclosures for village primary.
- 1/24-1/31/23 DATES for holding party caucus, Sec. 6.202.1.
- 1/26-2/2/23 DATES for filing certificate of party nomination, Sec. 6-210.2.a.
- 1/31/23 VILLAGE PRIMARY (if nominations are made at village primary) Sec. 6-202.1.
- 1/27-2/3/23 DATES to file general written objections to certification of party nomination or day after certification is received by the board of elections if such certification is mailed within the time permitted by law, whichever is later. Written specifications of objections must be filed within two days thereafter, Sec. 6-212.
- 2/3/23 LAST day to file general written objections to certificate of party nominations, or day after certificate is received by the board of elections if such certificate is mailed within the time permitted by law, whichever is later. Written specifications of objections must be filed within two days thereafter, Sec. 6-212.
- 2/6/23 LAST day to file certificate of acceptance or declination of party nomination, Sec. 6-210.2.b.
- 2/7/23 LAST day to file general written objections to certificate of declination or acceptance for party nominations, or day after certificate is received by the board of elections if such certificate is mailed within the time permitted by law, whichever is later. Written specifications of objections must be filed within two days thereafter, Sec. 6-212.
- 2/7-2/14/23 DATES to file independent nominating petition, Sec. 6-210.3.
- 2/8/23 LAST day to fill vacancy caused by declination of party nomination, Sec. 6-210.2.c. (not later than 41 days prior to the election).
- 2/10/23 THIRD filing of Financial Disclosures for village primary.
- 2/15/23 LAST day to file general written objections to independent petition, or day after petition is received by the board of elections if such petition is mailed within the time permitted by law, whichever is later. Written specifications of objections must be filed within two days thereafter, Sec. 6-212.
- 2/17/23 LAST day to file written specifications of objections to independent petitions.
- 2/17/23 FIRST filing of Financial Disclosures for village election.

## Westchester County Board of Elections

- 2/17/23 LAST day to file certificate of acceptance or declination of Independent Nomination. NOT LATER THAN 3 DAYS AFTER THE LAST DAY TO FILE THE PETITION, Sec. 6-210.3.b.
- 2/21/23 LAST day to file certificate to fill vacancy caused by declination of independent nomination, NOT LATER THAN 3 DAYS AFTER THE LAST DAY TO FILE THE PETITION, Sec. 6-210.3.c.
- 3/1/23 LAST day to file a petition to cause a permissive referendum to appear in the General Election ballot.
- \*3/6/23 LAST day to postmark application for absentee ballot by mail, Sec. 8-400.2.c. (15 days prior to election).
- 3/10/23 SECOND filing of Financial Disclosures for village election.
- 3/10/23 LAST day for voter to register with BOE to vote in village election.
- 3/15/23 LAST day to mail absentee ballot to qualified voters. Sec. 8-402.4.
- 3/20/23 LAST day for applicant or agent to apply in person, at the Board of Elections for absentee ballot, Sec. 8-400.2.c.
- 3/21/23 LAST day to postmark ballot.
- 3/21/23 LAST day to deliver ballot in person to BOE.
- 3/21/23 Election 6:00 am to 9:00 pm
- 3/22/23 Village to return election bags to Board, Sec. 9-124.3.b.
- 3/28/23 LAST day for BOE to receive ballot (7 days after the election) Sec. 8-412.
- 3/28/23 LAST day for BOE to re-canvass, Sec. 9-208.1.
- 4/17/23 THIRD filing of Financial Disclosures for village election.

### **GUIDELINES TO REMEMBER:**

- General written objections to designating or independent petitions as well as certificates of party nomination, acceptance or declination must be filed within (1) one day of the petition or certificate filing date.
- Written specifications of objections must then be filed within (2) two days of the date that the general written objection was filed.
